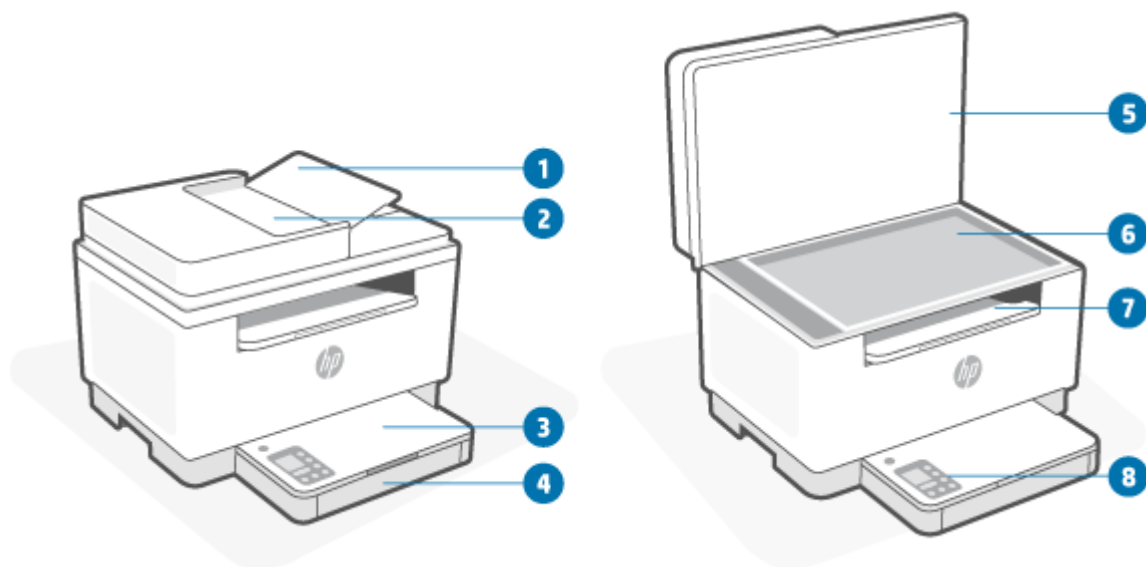

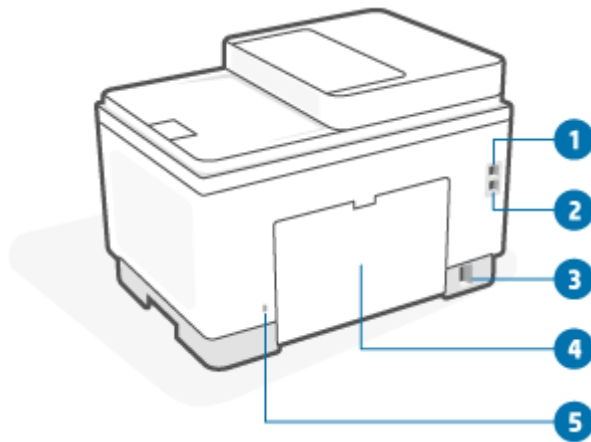

# Control panel display

## Control panel elements

The printer has the following control panel elements.




Feature	Description
1	 Wireless icon (some models only) If the wireless icon is lit, then there is a stable wireless connection. If an exclamation icon appears beside the wireless icon, see <a href="#">Wireless status of the printer</a> .
2	 Ethernet icon This indicates the printer is connected through a wired (Ethernet) connection.
3	 Wi-Fi Direct icon (wireless model only) The Wi-Fi Direct icon indicates that Wi-Fi Direct is on.
4	Character display Depending on the current mode, the characters display the following: <ul style="list-style-type: none"><li>• Number of copies being printed</li><li>• Copy settings (contrast and the reduce/enlarge setting)</li><li>• Animation to show that the device is busy</li><li>• Error and status codes. For a list of printer display codes, see <a href="#">Interpret printer display codes</a>.</li></ul>
5	 Reduce/Enlarge (Scale) icon When displayed, the character display shows the current scaling factor (in percent).
6	 Lighter/Darker (contrast) icon When displayed, the character display shows the contrast setting (as a bar graphic).
7	 Number of Copies icon When displayed, the character display shows the number of copies currently selected for printing.

## Control panel modes

The appearance of the control panel display changes depending on the mode that the printer is in. Three common display modes are shown below.



### Copy mode

The display shows  (the Number of Copies icon), and the number of copies currently selected.




### Contrast mode

The display shows  (the Lighter/Darker icon), and the current setting.



### Scale mode (some models only)

The display shows  (the Reduce/Enlarge icon), and the current scale (as a percentage of the original size).



# Use the HP Smart app to print, scan, and manage

The HP Smart app can help you perform many different printer tasks, including the following:

- Set up and connect your printer.
- Print and scan documents and photos.
- Share documents through email and other applications.
- Manage printer settings, check printer status, print reports, and order supplies.

HP Smart is supported on mobile devices and computers running on iOS, Android, Windows 10, and macOS 10.13 and later.



**NOTE:** At this time, the HP Smart app might not be available in all languages. Some features are available only on specific printers or models. HP Smart does not support all file formats. See [Get more information about HP Smart](#).

## To install HP Smart and open the app

Complete the following steps to install and open HP Smart, connect your printer, and begin using the app.

1. Visit [123.hp.com](https://123.hp.com) to download and install HP Smart on your device.



### NOTE:

- **iOS, Android, Windows 10, and macOS devices:** You can also download HP Smart from the respective app stores for the device.
  - **Windows 7:** You can download the HP printer software from [123.hp.com](https://123.hp.com), install the software, and connect the printer wirelessly using the software.
2. Open HP Smart after installation.
    - **iOS/Android:** From the mobile device desktop or app menu, tap HP Smart.
    - **Windows 10:** From the computer desktop, click **Start**, and then select **HP Smart** from the app list.
    - **macOS:** From the Launchpad, select HP Smart.

# Connect your printer to a Wi-Fi network using HP Smart

---

 **NOTE:** This section is applicable to wireless printers only.


---

Install the HP Smart app on your computer or mobile device and use the app to set up or connect the printer to your Wi-Fi network.

For information about HP Smart including where to download the app, see [Use the HP Smart app to print, scan, and manage](#).

1. Make sure your computer or mobile device is connected to your Wi-Fi network. On your mobile device, turn on Bluetooth and location services.


---

 **NOTE:** HP Smart uses Bluetooth for printer setup. It does not support Print using Bluetooth.


---

2. If your printer Wi-Fi was previously turned off, make sure to turn it on. For more information about wireless status, see [To turn on or off the wireless capabilities of the printer](#).
3. If the printer is no longer in wireless setup mode, restore the printer network settings. See [To restore network settings to default settings](#).


---

 **NOTE:** For some printers or models, the purple light will start pulsing in the Status light bar or the Wireless light will blink when the printer is in wireless setup mode.

---

4. Open the HP Smart app on your computer or mobile device. See [Use the HP Smart app to print, scan, and manage](#).
5. From HP Smart, click or tap  (the Plus icon) or **Add Printer**, and then choose the option to select or add a printer. If prompted, allow Bluetooth and location permissions.  
Follow the instructions to add the printer to your network.
6. When prompted, create an HP account and register the printer.


---

 **NOTE:** When the printer is connected successfully, the Wireless light stops blinking and remains lit (for all Wireless models). See [Printer views](#).

---

# Connect your printer to a Wi-Fi network using Wi-Fi Protected Setup (WPS)

This wireless setup method can be used if your router has a WPS button. If the router does not have this button, it is recommended that you connect the printer using the HP Smart app. See [Connect your printer to a Wi-Fi network using HP Smart](#).

1. Make sure your router and printer are not too far from each other.
2. From the printer control panel, press and hold  (the Wireless button) for at least 3 seconds to start WPS.


The Wireless light blinks.

3. Press the WPS button on your router.

---

 **NOTE:**

- Be sure to press the WPS button on the router within 2 minutes.
- When the printer is connected successfully, the Wireless light stops blinking and remains lit (for all Wireless models). See [Printer views](#).

4. Open the HP Smart app on your computer or mobile device. See [Use the HP Smart app to print, scan, and manage](#).
5. From HP Smart, click or tap  (the Plus icon) or **Add Printer**, and then choose the option to select or add a printer.

Follow the instructions to add the printer to your network.

6. When prompted, create an HP account and register the printer.


## Connect your printer to an Ethernet network

If your Ethernet network does not have an Internet connection, connect the printer wirelessly to the HP Smart app. See [Connect your printer to a Wi-Fi network using HP Smart](#).


1. Make sure your computer is connected to the router.
2. Connect your printer and router using an Ethernet cable. (Ethernet cable sold separately.)

---

 **NOTE:**

- The Wi-Fi connection is automatically disabled when you connect the Ethernet cable.
  - To connect the printer wirelessly, disconnect the Ethernet cable and connect the printer to your wireless network using HP Smart. See [Connect your printer to a Wi-Fi network using HP Smart](#).
3. Open the HP Smart app on your computer or mobile device. See [Use the HP Smart app to print, scan, and manage](#).
  4. From HP Smart, click or tap  (the Plus icon) or **Add Printer**, and then choose the option to select or add a printer.  
Follow the instructions to add the printer to your network.
  5. When prompted, create an HP account and register the printer.













## Connect your printer using a USB cable

3. From HP Smart, click or tap  (the Plus icon) or **Add Printer**, and then choose the option to select or add a printer.  
Follow the instructions to add the printer.
4. When prompted, create an HP account and register the printer.


# Change wireless settings

You can set up and manage the wireless connection for your printer. This includes printing information about network settings, turning the wireless function on or off, and restoring wireless settings.





## Wireless status of the printer

## To turn on or off the wireless capabilities of the printer

Press  (the Wireless button) to turn on or off the printer wireless capabilities.

## To restore network settings to default settings

1. Press and hold  (the Information button) for 3 seconds, and then release the button. All control panel buttons will light up.
2. Press and hold  (the Wireless button) and  (the Cancel button). The printer restarts and, depending on your printer model, the Status light pulses purple or  (the Wireless button) starts blinking blue. This indicates that the printer is in wireless setup mode. You can now set up a wireless connection between the printer and your device.



**NOTE:** Use the HP Smart app to connect the printer wirelessly.

## USB to a wireless connection

### Windows 10/macOS

1. Unplug the USB cable from the printer.
2. Make sure your computer or mobile device is connected to your Wi-Fi network. On your mobile device, turn on Bluetooth and location services.
3. If your printer Wi-Fi was previously turned off, make sure to turn it on. For more information about wireless status, see [To turn on or off the wireless capabilities of the printer](#).
4. If the printer is no longer in wireless setup mode, restore the printer network settings. See [To restore network settings to default settings](#).
5. Open the HP Smart app on your computer or mobile device. See [Use the HP Smart app to print, scan, and manage](#).
6. When prompted, create an HP account and register the printer.
7. Follow the on-screen instructions to connect the printer to your Wi-Fi network.

### Windows 7


1. Open the HP printer software.

2. In the printer software, click **Tools**, and then click **Device Setup & Software**.
3. Select **Convert a USB connected device to wireless**. Follow the on-screen instructions.

## Load paper

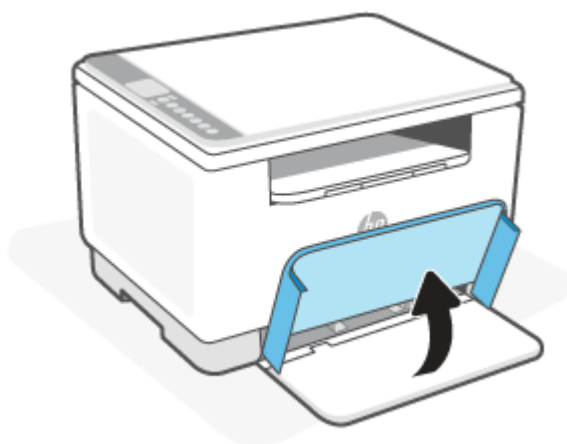
The following information describes how to load paper into the input tray.


 **NOTE:** To avoid paper jams:

- Never add or remove paper from the input tray during printing.
- Before loading the input tray, remove all of the paper from the input tray and straighten the stack.
- Use paper that is not wrinkled, folded, or damaged.
- Always use 1 size paper. For example, do not place A5 paper over A4 size paper.
- Always push the paper guides to ensure paper does not slant/skew while picking up by printer.

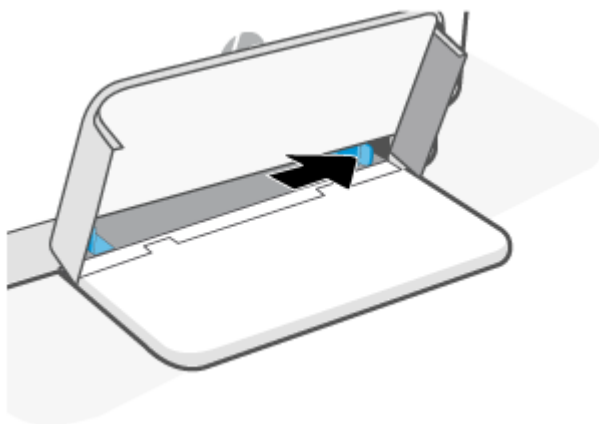
### To load paper

1. Remove paper from the input tray, if any.

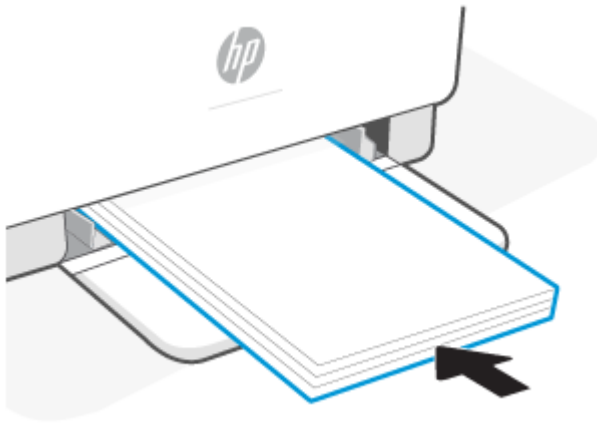


 **TIP:** To load Legal-size paper, lift the printer cover and, if necessary, leave it open. Depending on your printer model, you might also need to lower the tray door.

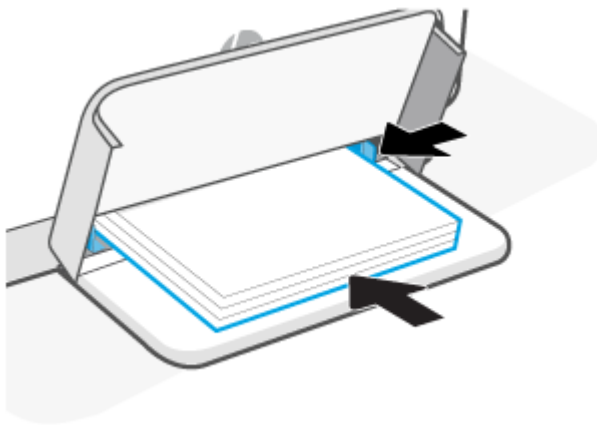
2. Slide the paper guides to the edges of the input tray.



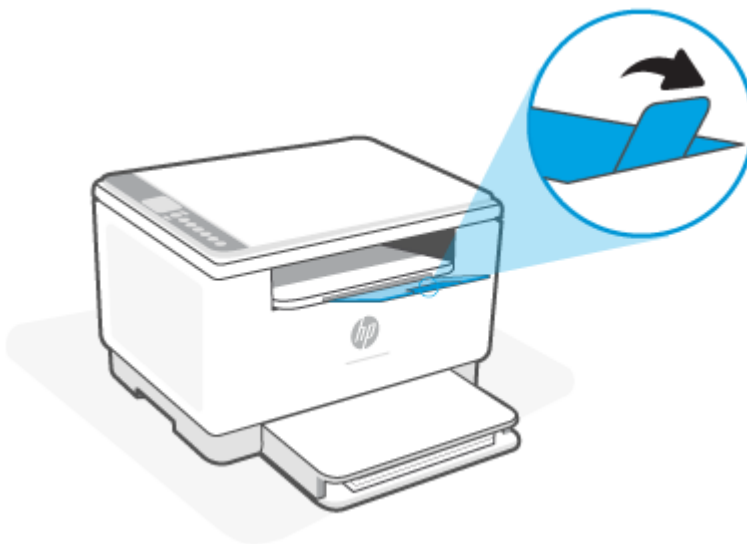
3. Insert the stack of paper into the input tray with the top forward and the side to be printed on facing up.



4. Slide the paper guides until they touch the edges of the media.



5. Lower the tray cover and extend the output tray.

## To load envelopes

1. Remove all paper from the input tray.
2. Insert the envelope into the middle of the input tray, with the short, postage end toward the back of the tray. The side to be printed on should face up.



3. Slide the paper guides until they touch the edges of the media.
4. Lower the tray cover and extend the output tray.

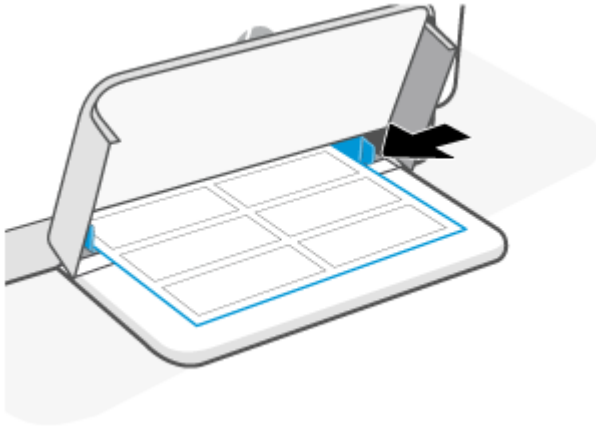
# Load labels

The following information describes how to load paper into the input tray.

## To load labels

1. Remove all paper from the input tray.
2. Insert the sheet of labels into the middle of the input tray, with the top edge of the sheet toward the back of the tray. The side to be printed on should face up.



3. Slide the paper guides until they touch the edges of the media.
4. Lower the tray cover and extend the output tray.

## Load an original on the scanner glass

You can copy or scan originals by loading them on the scanner glass.

---

 **NOTE:**


- The scanner might not work correctly if the scanner glass and lid backing are not clean.
  - Remove all originals from the document feeder tray before lifting the lid on the printer.
- 

### To load an original on the scanner glass

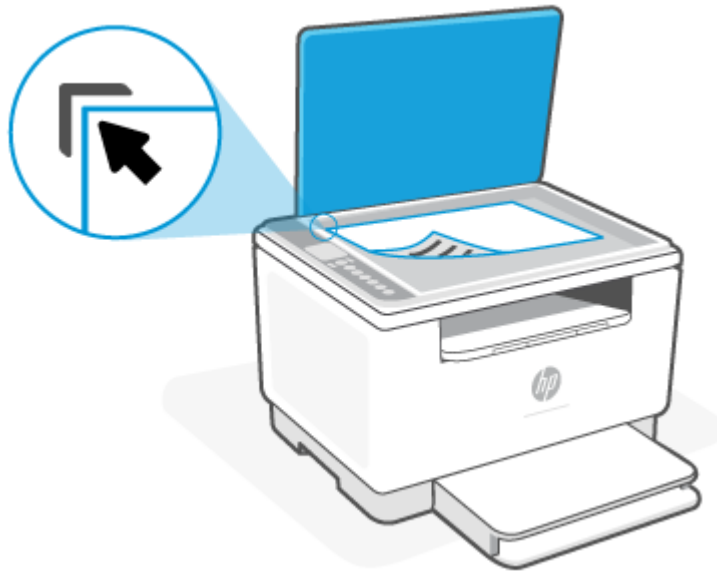
1. Lift the scanner lid.



2. Load your original print-side down and align it with the marking on the rear left corner of the glass.

 **TIP:** For more help on loading an original, refer to the engraved guides along the edge of the scanner glass.

---



3. Close the lid.



## Load an original in the document feeder (some models only)

You can copy or scan a document by placing it in the document feeder.

**CAUTION:** Do not load photos in the document feeder, this might cause damage to your photos. Use only paper that is supported by the document feeder.

**NOTE:** Some features, such as the **Fit to Page** copy feature, do not work when you load your originals in the document feeder. For those features to work, load your originals on the scanner glass.

### To load an original in the document feeder

1. Load your original print-side up into the document feeder.
  - a. If you are loading an original printed in portrait orientation, place the pages so that the top edge of the document goes in first. If you are loading an original printed in landscape orientation, place the pages so that the left edge of the document goes in first.
  - b. Slide the paper into the document feeder until you hear a tone.

**TIP:** For more help on loading originals in the document feeder, refer to the diagram on the document feeder tray.



2. Slide the paper-width guides inward until they stop at the left and right edges of the paper.

**NOTE:** Depending on your printer, the Status light blinks or a solid green light appears on the bar when the printer is initializing, cooling down, performing automatic cleaning routines, or shutting down.

To provide productive printing, this printer may automatically enter cool-down mode under certain environmental conditions. This process might take several minutes. When the printer is cooling down, print jobs might pause, but these jobs will continue when the engine is ready.

---

## Print from a Windows computer

1. Make sure you have installed the HP Smart app. See [Use the HP Smart app to print, scan, and manage.](#)
2. Open the document you wish to print.
3. From the **File** menu in your software program, select the **Print** option.
4. Click the button that opens the **Properties** dialog box.

Depending on your software application, this button might be called **Properties**, **Options**, **Setup**, or **Preferences**.

5. Make sure your printer is selected.
6. Change any print settings, and Click **OK**.
7. Click **Print** or the **OK** button to print the job.

## Print from a Mac computer

1. Make sure you have installed the HP Smart app. See [Use the HP Smart app to print, scan, and manage](#).
2. From the computer, open **System Preference**, and select **Printers and Scanners**.
3. Click + (the Add button/icon), select the printer from the printer list, and then click **Add**.
4. Once connected, open the document you wish to print and use the **Print** command.
5. Make sure the desired printer is selected.
6. Change any print settings.
7. Click **Print** to print the document.

## Print with mobile devices

You can use the HP Smart app to print documents and photos from your mobile device, social media account, or cloud storage. See [Use the HP Smart app to print, scan, and manage](#).

You can also print directly from your mobile devices using AirPrint (iOS) or HP Print Service Plugin (Android):

- **iOS:** Devices running iOS 4.2 or later have AirPrint pre-installed.
- **Android:** Download the HP Print Service Plugin from the Google Play Store or your favorite app store, and then enable it on your device.



**NOTE:** You can print using HP Smart or AirPrint/HP Print Service Plugin when the mobile device is on the same network as the printer or a different network (using Wi-Fi Direct).

### Print while connected to same Wi-Fi network

You can print documents and photos from your mobile device when the device is on the same Wi-Fi network as the printer.

With Wi-Fi Direct, you can directly connect your computer or mobile device to the printer and print wirelessly—without connecting your computer or mobile device to an existing wireless network.

**NOTE:**

- Up to 5 computers and mobile devices can connect to the printer using Wi-Fi Direct connection.


**To turn Wi-Fi Direct on or off from the control panel:**

1. Press and hold  (the Information button) for three seconds and then release the button.

All control panel buttons will light up.

2. Press  (the Resume button) and  (the Wireless button) at the same time.



**TIP:** Press  (the Information button) to print a report to check Wi-Fi Direct status and password.

## Make a copy

Follow these steps to make a copy from the scanner glass:

1. Load the document on the scanner glass according to the indicators on the printer.
2. Press  (the Menu button) to choose any of the following copy settings.
  - Use  (the Minus button) and  (the Plus button) to adjust the number of copies to print.
  - Select  (the Lighter/Darker) setting, and then use  (the Minus button) and  (the Plus button) to adjust the darkness setting for the current copy job.
3. Press  (the Copy button) to start copying.

---

 **TIP:** If your device has a camera, you can use the HP Smart app to scan a printed document or photo with the device camera. You can then use HP Smart to edit, save, print, or share the image.

---

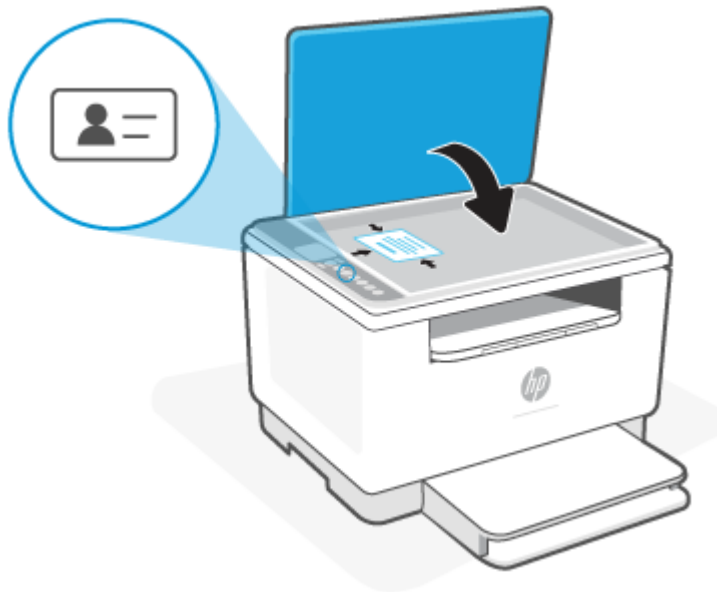
## Copy an identification (ID) card

Use the ID Copy feature to copy both sides of identification card, or other small-size documents, onto the same side of one sheet of paper. The printer prints both images at the same time.

1. Open the scanner lid and place the ID card on the top half of the scanner glass as shown.



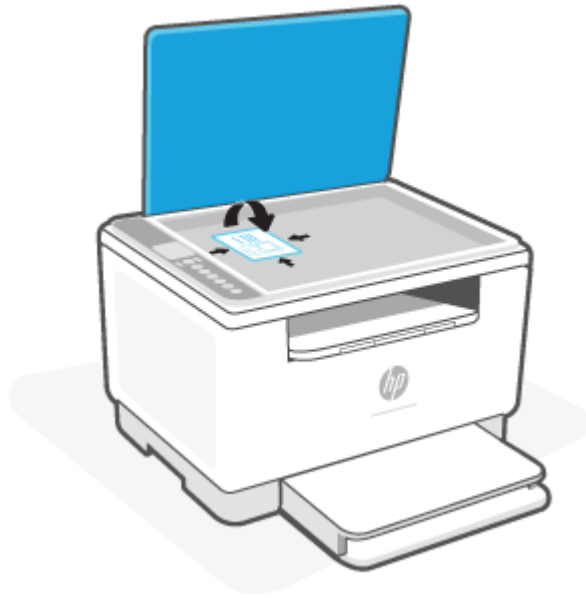
2. Close the scanner lid and press  (the ID Copy button) to start copying.




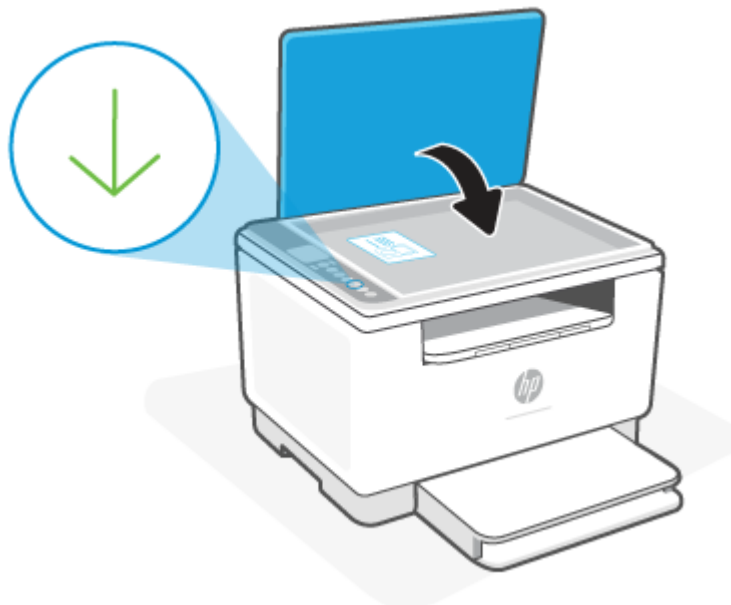
When the copying is done,  (the Open Lid light) is lit and "P2" appears on the display.



3. Open the scanner lid, flip over the ID card and place on the same section of the scanner glass.



4. Close the scanner lid and press  (the Resume button) to start scanning the second side and print.



## Scan using HP Smart (iOS/Android, Windows 10, and macOS)

You can use the HP Smart app to scan documents or photos from the printer's scanner, and you can also scan using your device camera. HP Smart includes editing tools that allow you to adjust the scanned image before saving or sharing. You can print, save your scans locally or in cloud storage, and share them via email, SMS, Facebook, Instagram, etc. To scan with HP Smart, follow the instructions provided in the appropriate section below, depending on the type of device you are using.

## Set up Web Services

1. Before you set up Web Services, make sure your printer is connected to the Internet.
2. Open the printer home page (the embedded web server or EWS). See [To access and use the Embedded Web Server \(EWS\)](#).
3. Click the **HP Web Services** tab.
4. In **Web Services Settings**, click **Enable**, and follow the on-screen instructions to accept the terms of use.
5. If prompted, choose to allow the printer to check for and install printer updates.

---

 **NOTE:**

- If prompted for a password, enter the PIN from the label on your printer. See [Things to note when accessing EWS](#).
  - If prompted for proxy settings and if your network uses proxy settings, follow the on-screen instructions to set up a proxy server. If you do not have the details, contact your network administrator or the person who set up the network.
  - If a printer update is available, the printer downloads and installs the update and then restarts automatically. Repeat the instructions above to set up **HP Web Services**.
- 
6. After the printer is connected to the HP server, the printer prints an information sheet. Follow the instructions on the information sheet to finish setting up Web Services.

## Remove Web Services

## Update the printer

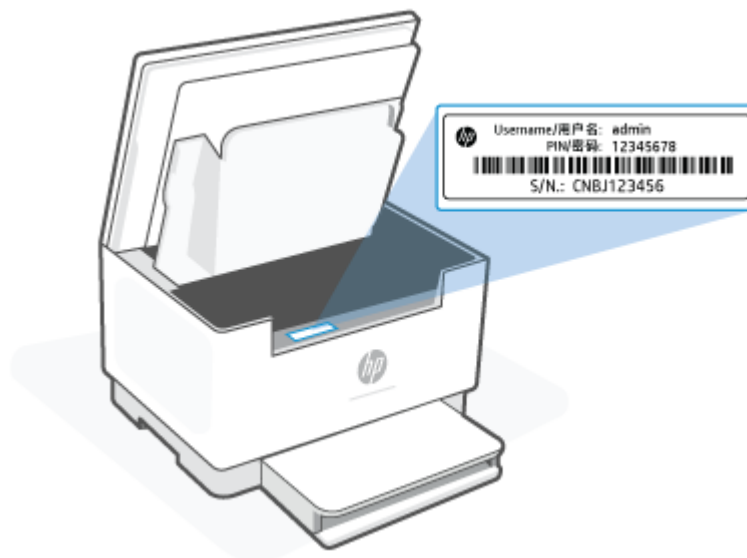
## To access and use the Embedded Web Server (EWS)

You can open EWS using one of the following:

- HP Smart app
- HP printer software
- Web browser using IP address
- Web browser using Wi-Fi Direct connection

### Things to note when accessing EWS

- If the web browser displays a message indicating that the website is unsafe, select the option to continue. Accessing the website will not harm your device.
- If prompted, enter the default user name and password of the printer.
  - **User Name:** admin
  - **Password:** Open the cartridge access door, and see the label inside the printer.




- Depending on how the printer is connected, some features in EWS might not be available.
- EWS is not accessible beyond the network firewall.

## To open EWS using HP Smart (iOS, Android, and Windows 10)

1. Open the HP Smart app on your computer or mobile device. See [Use the HP Smart app to print, scan, and manage](#).
2. From HP Smart, select your printer, and then click or tap **Advanced Settings**.

## To open EWS using an IP address (Wi-Fi or Ethernet connection)

1. Find out the IP address. Press  (the Information button) on the printer to print an information page.
2. Open a web browser, type the IP address or hostname in the address bar, and then click or tap **Enter**.

## To open EWS using an IP address (Wi-Fi Direct connection)

1. Make sure your device and the printer are connected using Wi-Fi Direct. See [Print without connecting to same Wi-Fi network \(Wi-Fi Direct\)](#).
2. Open a web browser, type the following IP address or hostname of the printer in the address bar, and then click or tap **Enter**.

**IP Address:** 192.168.223.1

## To open EWS using HP Printer software (Windows 7)

1. From the computer desktop, click **Start**, select **All Programs**, click **HP**, click the folder for the printer, select the icon with the printer's name, and then open **HP Printer Assistant**.
2. In the **HP Printer Assistant**, select **Print** tab.
3. Select **Printer Home Page (EWS)**.



## Configure IP network settings

Use the following sections to configure the printer network settings.

### View or change network settings

Use the Embedded Web Server to view or change IP configuration settings.

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. Click the **Networking** tab to obtain network information. Change settings as needed.

### Rename the printer on a network

To rename the printer on a network so that it can be uniquely identified, use the Embedded Web Server.

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. Open the **System** tab.
3. On the **Device Information** page, the default printer name is in the **Device Description** field. You can change this name to uniquely identify this printer.



---

**NOTE:** Completing the other fields on this page is optional.

---

4. Click the **Apply** button to save the changes.

### Manually configure IPv4 TCP/IP parameters

Use the EWS to manually set an IPv4 address, subnet mask, and default gateway.

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. On the **Networking** tab, click **IPv4 Configuration** in the left navigation pane.
3. From the **IP Preferred Address Method** drop-down, select **Manual**, and then edit the IPv4 configuration settings.
4. Click the **Apply** button.

## Assign or change the system password using the Embedded Web Server

Assign an administrator password for access to the printer and the HP Embedded Web Server so that unauthorized users cannot change the printer settings.

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. On the **System** tab, click the **Administration** link in the left navigation pane.
3. In the area labeled **Product Security**, enter the password in the **Password** field.
4. Re-enter the password in the **Confirm Password** field.
5. Click the **Apply** button.



---

**NOTE:** Make note of the password and store it in a safe place.

---

## Change energy-conservation settings

The printer includes several economy features to conserve energy and supplies.

### Set the Sleep/Auto Off After Inactivity setting

Use the EWS to set the amount of idle time before the printer enters sleep mode.


Complete the following procedure to change the Sleep/Auto Off After Inactivity setting:

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. Click the **System** tab, and then select **Energy Settings**.
3. From the **Sleep/Auto Off After Inactivity** drop-down, select the time for the delay.
4. Click the **Apply** button.

### Set the Shut Down After Inactivity delay and configure the printer to use 1 watt or less of power

Use the EWS to set the amount of time before the printer shuts down.

---

 **NOTE:** After the printer shuts down, the power consumption is 1 watt or less.

---

Complete the following procedure to change the Shut Down After Inactivity setting:

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. Click the **System** tab, and then select **Energy Settings**.
3. From the **Shut Down After Inactivity** drop-down, select the time for the delay.


---

 **NOTE:** The default value is **4 hours**.

---

4. Click the **Apply** button.


### Set the Delay Shut Down setting

Use the EWS to select whether or not the printer delays shutting down after  (the Power button) is pressed.

Complete the following procedure to change the Delay Shut Down setting:

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. Click the **System** tab, and then select **Energy Settings**.
3. Select or clear the **Delay when ports are active** option.

---

 **NOTE:** When this option is selected the printer will not shut down unless all ports are inactive. An active network link will prevent the printer from shutting down.

## Configure the HP toner-cartridge-protection supply settings

Use HP Cartridge Policy and Cartridge Protection to control which cartridges are installed in the printer and protect the cartridges that are installed from theft.

- **Cartridge Policy:** This feature protects the printer from counterfeit toner cartridges by allowing only genuine HP cartridges to be used with the printer. Using genuine HP cartridges ensures the best possible print quality. When someone installs a cartridge that is not a genuine HP cartridge, the printer control panel displays a message that the cartridge is unauthorized and it provides information explaining how to proceed.
- **Cartridge Protection:** This feature permanently associates toner cartridges with a specific printer, or fleet of printers, so they cannot be used in other printers. Protecting cartridges protects your investment. When this feature is enabled, if someone attempts to transfer a protected cartridge from the original printer into an unauthorized printer, that printer will not print with the protected cartridge. The printer control panel displays a message that the cartridge is protected, and it provides information explaining how to proceed.

---

 **CAUTION:** After enabling cartridge protection for the printer, all subsequent toner cartridges installed in the printer are automatically and *permanently* protected. To avoid protecting a new cartridge, disable the feature *before* installing the new cartridge.

---

Turning the feature off does not turn off protection for cartridges that are currently installed.

---

Both features are off by default. Follow these procedures to enable or disable them.

## Enable or disable the Cartridge Policy feature

The Cartridge Policy feature can be enabled or disabled using the embedded web server (EWS).



---

**NOTE:** Enabling or disabling this feature might require entering an administrator password.

---

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. Click the **System** tab, and then select **Supply Settings**.
3. From the **Cartridge Policy** drop-down menu, select **off** or **Authorized HP**.
4. Click the **Apply** button.

# Replace the toner cartridge

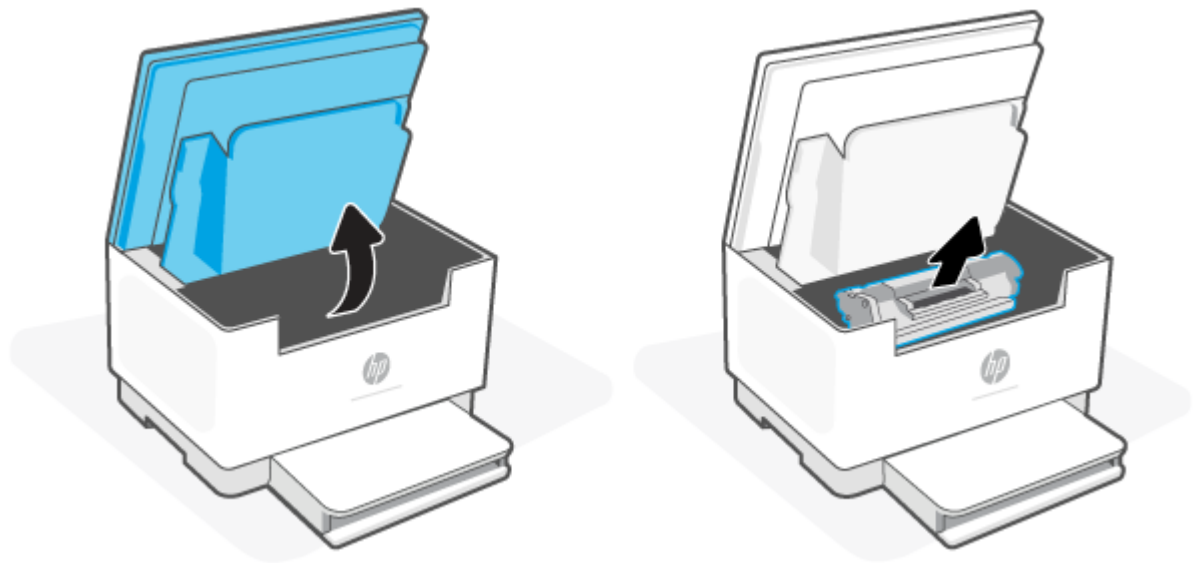
## Cartridge information

Continue printing with the current cartridge until redistributing the toner no longer yields acceptable print quality. To redistribute the toner, remove the toner cartridge from the printer and gently rock the cartridge back and forth about its horizontal axis. For graphical representation, see cartridge replacement instructions. Reinsert the toner cartridge into the printer and close the cover.

## Remove and replace the toner cartridge

When a print cartridge approaches the end of useful life, you can continue printing with the current cartridge until redistributing the toner no longer yields acceptable print quality.

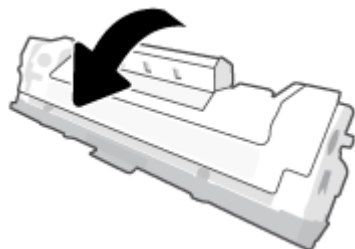
1. Open the cartridge access door, and then remove the old print cartridge.



2. Remove the new print cartridge from the packaging. Place the used print cartridge in the bag and box for recycling.

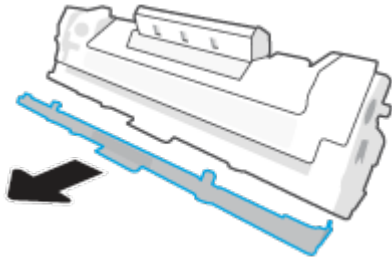
**CAUTION:** To prevent damage to the print cartridge, hold the print cartridge at each end. Do not touch the protective cover or roller surface.

3. Grasp both sides of the print cartridge and gently rock the print cartridge to distribute the toner evenly inside the cartridge.

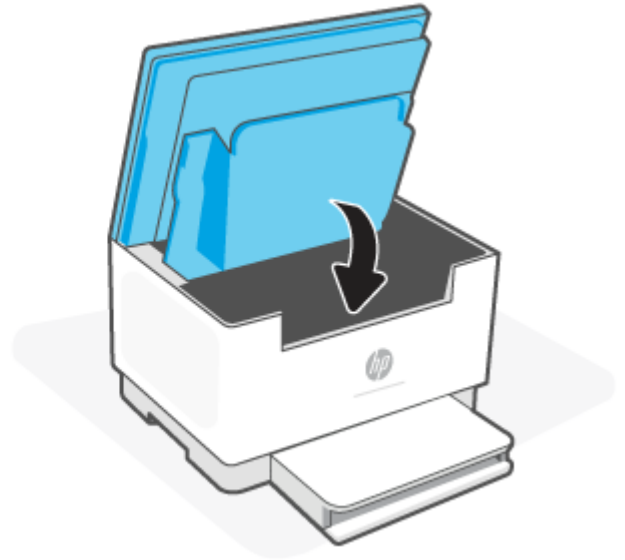
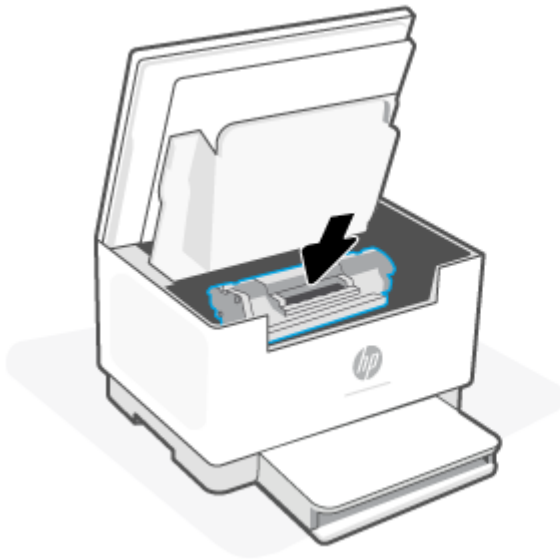




4. Remove the cover from the print cartridge.



5. Insert the print cartridge in the product, and then close the cartridge access door.



---

**⚠ CAUTION:** If toner gets on your clothing, wipe it off with a dry cloth and wash the clothing in cold water. *Hot water sets toner into the fabric.*

### The Attention light is on


---

Attention light on, Paper light blinks.

If  (the Paper light) blinks, the printer might be out of paper (see [Load paper](#)) or paper might be jammed (see [Clear paper jams](#)). If you are sending a manual feed job, load paper, and press  (the Resume button) to continue.

---

Attention light on, Cartridge light blinks.

If  (the Cartridge light) blinks, the cartridge might be very low or there is a cartridge error (such as incompatible, unauthorized, protected). Replace the toner cartridge.

**NOTE:** There will be no Attention state if the printer is configured to continue printing when the toner cartridge is very low.

# Cartridge low

## Cartridge is low

Actual cartridge life remaining may vary. Consider having a replacement available to install when print quality is no longer acceptable. The cartridge does not need to be replaced now.

Continue printing with the current cartridge until redistributing the toner no longer yields acceptable print quality. To redistribute the toner, remove the toner cartridge from the printer and gently rock the cartridge back and forth about its horizontal axis. For graphical representation, see cartridge replacement instructions. Reinsert the toner cartridge into the printer and close the cover.

## Cartridge is very low

Actual cartridge life remaining may vary. Consider having a replacement available to install when print quality is no longer acceptable. The cartridge does not need to be replaced now unless the print quality is no longer acceptable.

Once an HP toner cartridge has reached Very Low, HP's Premium Protection Warranty on that toner cartridge has ended.

## Change the “Very Low” settings

You can change the way the printer reacts when supplies reach the Very Low state. You do not have to re-establish these settings when you install a new toner cartridge.

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. Select the **System** tab, and then select **Supply Settings**.
3. Select one of the following options from the **Very Low Setting (Black Cartridge)**: drop-down list:
  - Select the **Stop** option to set the printer to stop printing until you replace the cartridge.
  - Select the **Continue** option to set the printer to alert you that the cartridge is very low, but to continue printing.

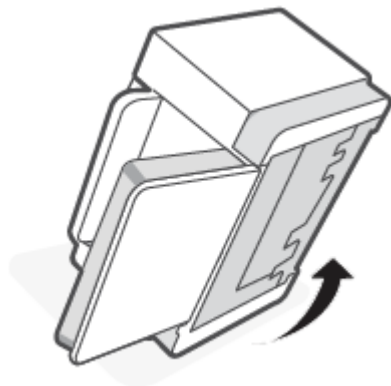
If the product does not pick up paper from the input tray, try these solutions.

1. Open the product and remove any jammed sheets of paper.
2. Load the tray with the correct size of paper for your job.
3. Make sure the paper size and type are set correctly.
4. Make sure the paper guides in the tray are adjusted correctly for the size of paper. Adjust the guides to the appropriate indentation in the tray.
5. Clean the pickup roller.

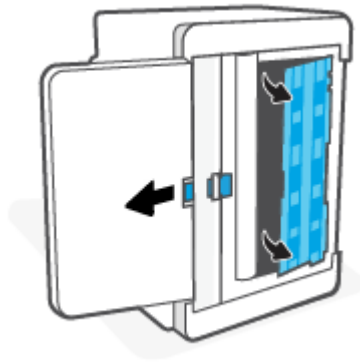

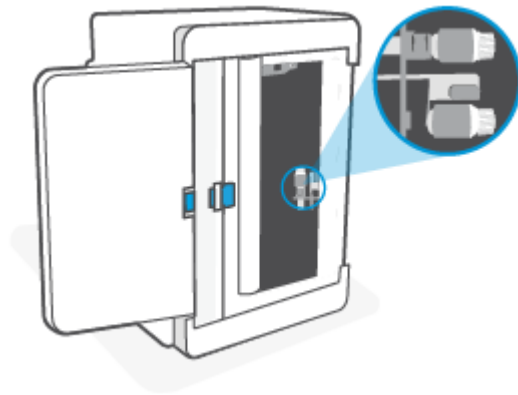

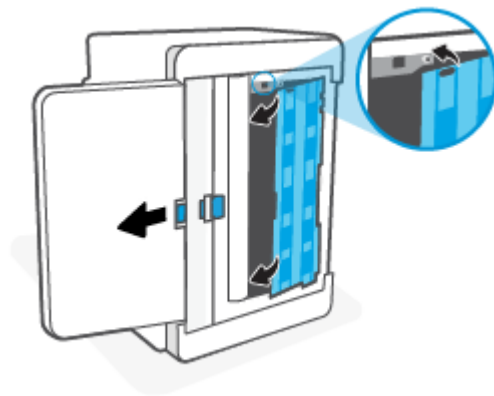


6. Dampen a soft, lint-free cloth with alcohol or water, and then wipe each roller.

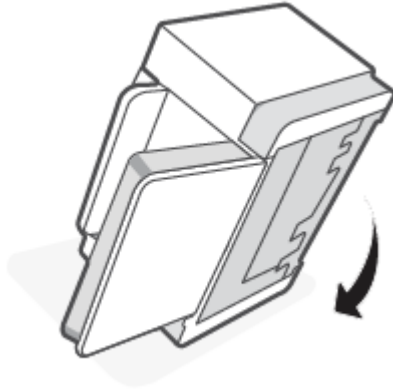

7. Wait approximately 10 minutes to allow the pickup roller to dry completely.
8. While holding onto the blue latch, align and insert the panel as shown. Release the blue latch to lock the panel in the place.

10. Reload the stack of paper into the input tray.
11. Plug the power cord back into the printer, and then turn on the printer.

## The product picks up multiple sheets of paper

If the product picks up multiple sheets of paper from the input tray, try these solutions.

1. Remove the stack of paper from the input tray and rotate it 180 degrees, and flip it over. Return the stack of paper to the input tray.
2. Use only paper that meets HP specifications for this product.
3. Use paper that is not wrinkled, folded, or damaged. If necessary, use paper from a different package.
4. Make sure the input tray is not overfilled. If it is, remove the entire stack of paper from the tray, straighten the stack, and then return some of the paper to the input tray.
5. Make sure the paper guides in the tray are adjusted correctly for the size of paper. Adjust the guides to the appropriate indentation in the tray.
6. Make sure the printing environment is within recommended specifications.

## Frequent or recurring paper jams?

Follow these steps to solve problems with frequent paper jams. If the first step does not resolve the problem continue with the next step until you have resolved the problem.

1. If paper has jammed in the printer, clear the jam and then print a test page to test the printer.
2. Check that the tray is configured for the correct paper size and type.
  - a. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
  - b. Click the **System** tab, and then click the **Paper Setup** page.
  - c. Select the type of paper that is in the tray.
3. Turn the printer off, wait 30 seconds, and then turn it on again.
4. [Print a cleaning page](#) to remove excess toner from inside the printer.
5. Print a test page to test the printer.

If none of these steps resolves the problem, the printer might need service. Contact support.

## Introduction

The following information provides troubleshooting steps to resolve print-quality problems, including the following problems:

- Smears
- Fuzzy print
- Dark print
- Light print
- Streaks
- Missing toner
- Scattered dots of toner
- Loose toner
- Skewed images

To resolve these or other print-quality problems, try the following solutions in the order presented.

## Print from a different software program

Try printing from a different software program. If the page prints correctly, the problem is with the software program from which you were printing.

If the page does not print correctly, try updating the printer and print again. See [Update the printer](#).

## Check the paper-type setting for the print job

Check the paper type setting when printing from a software program and the printed pages have smears, fuzzy or dark print, curled paper, scattered dots of toner, loose toner, or small areas of missing toner.

## Check the paper type setting on the printer

Verify that the tray is loaded with the correct type of paper.

## Check the paper type setting (Windows)

1. From the software program, select the **Print** option.
2. Select the printer, and then click the **Properties** or **Preferences** button.
3. Check the paper settings.


## Check the paper type setting (OS X)

1. Click the **File** menu, and then click the **Print** option.
2. In the **Printer** menu, select the printer.
3. By default, the print driver displays the **Copies & Pages** menu. Open the menus drop-down list, and then click the **Finishing** menu.
4. Select a type from the **Media Type** drop-down list.

## Check toner-cartridge status

Follow these steps to check the estimated life remaining in the toner cartridges and if applicable, the status of other replaceable maintenance parts.

### Step one: Find supplies information

From the printer control panel, press  (the Information button) to print an information report.

### Step two: Check supplies status

1. Open EWS (see [To access and use the Embedded Web Server \(EWS\)](#)) to look at the supplies status report of the toner cartridges and if applicable, the status of other replaceable maintenance parts.

Print quality problems can occur when using a toner cartridge that is at its estimated end of life. The configuration report indicates when a supply level is very low.

Once an HP toner cartridge has reached Very Low, HP's Premium Protection Warranty on that toner cartridge has ended.

The toner cartridge does not need to be replaced now unless the print quality is no longer acceptable. Consider having a replacement available to install when print quality is no longer acceptable.

If you determine that you need to replace a toner cartridge or other replaceable maintenance parts, the configuration report lists the genuine HP part numbers.

2. Check to see if you are using a genuine HP cartridge.

A genuine HP toner cartridge has "HP" on it, or has the HP logo on it. For more information on identifying HP cartridges go to [www.hp.com/go/learnaboutsupplies](http://www.hp.com/go/learnaboutsupplies)

## Clean the cartridge

During the printing process, cartridges might be contaminated by paper dust and cause print quality issues such as background issues, vertical dark bands, or repetitive horizontal banding.

Follow these steps to improve the above mentioned print quality issues:

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. Click the **System** tab, and then click **Service**.
3. In the **Cartridge Cleaning Mode** area, click **Start** to begin the cleaning process.

## Print a cleaning page

During the printing process paper, toner, and dust particles can accumulate inside the printer and can cause print-quality issues such as toner specks or spatter, smears, streaks, lines, or repeating marks.

Use the following procedure to print a cleaning page.

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. On the **System** tab, click **Service**.
3. In the **Fuser Cleaning mode** area, click **Start** to begin the cleaning process.

## Visually inspect the toner cartridge

Follow these steps to inspect the toner cartridge.

1. Remove the toner cartridges from the printer, and verify that the sealing tape has been removed.
2. Check the memory chip for damage.
3. If you see any damage on the toner cartridge, replace the toner cartridge.
4. Reinstall the toner cartridge, and print a few pages to see if the problem has resolved.

## Check paper and the printing environment

### Step one: Use paper that meets HP specifications

Some print-quality problems arise from using paper that does not meet HP specifications.

- Always use a paper type and weight that this printer supports.
- Use paper that is of good quality and free of cuts, nicks, tears, spots, loose particles, dust, wrinkles, voids, staples, and curled or bent edges.
- Use paper that has not been previously printed on.
- Use paper that does not contain metallic material, such as glitter.
- Use paper that is designed for use in laser printers. Do not use paper that is designed only for use in Inkjet printers.
- Use paper that is not too rough. Using smoother paper generally results in better print quality.

## Step two: Check the environment

The environment can directly affect print quality and is a common cause for print-quality or paper-feeding issues. Try the following solutions:

- Move the printer away from drafty locations, such as open windows or doors, or air-conditioning vents.
- Make sure the printer is not exposed to temperatures or humidity outside of printer specifications.
- Do not place the printer in a confined space, such as a cabinet.
- Place the printer on a sturdy, level surface.
- Remove anything that is blocking the vents on the printer. The printer requires good air flow on all sides, including the top.
- Protect the printer from airborne debris, dust, steam, grease, or other elements that can leave residue inside the printer.

## Adjust Print Density

Complete the following steps to adjust the print density.

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. Click the **System** tab, and then select **System Setup** from the left navigation pane.
3. Select the correct density settings.
4. Click **Apply** to save the changes.

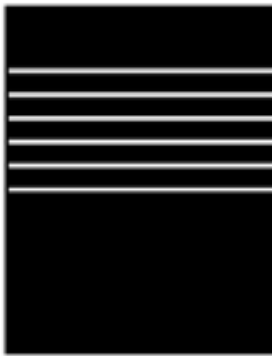

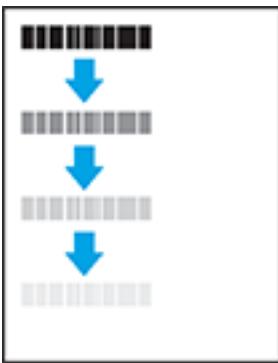




Image defects, no matter the cause, can often be resolved using the same steps. Use the following steps as a starting point for solving image defect issues.

1. Reprint the document. Print quality defects can be intermittent in nature or can go away completely with continued printing.
2. Check the condition of the cartridge. If a cartridge is in a **Very Low** state (it has passed the rated life), replace the cartridge.
3. Make sure that the driver and tray print mode settings match the media that is loaded in the tray. Try using a different ream of media or a different tray. Try using a different print mode.
4. Make sure that the printer is within the supported operating temperature/humidity range.
5. Make sure that the paper type, size, and weight are supported by the printer. See the printer support page at [www.hp.com/support/ljM232MFP](http://www.hp.com/support/ljM232MFP) for a list of the supported paper sizes and types for the printer.


 **NOTE:** The term “fusing” refers to the part of the printing process where toner is affixed to paper.

# Improve copy and scan image quality

## Introduction


If the printer is having image quality problems, first make sure you are using high-quality originals. If the problem still exists, try the following solutions in the order presented to resolve the issue.

## Check the scanner glass for dirt and smudges


Over time, specks of debris might collect on the scanner glass and white plastic backing, which can affect performance. Use the following procedure to clean the scanner.

1. Press  (the Power button) to turn the printer off, and then disconnect the power cable from the electrical outlet.
2. Open the scanner lid.
3. Clean the scanner glass and the white plastic backing underneath the scanner lid with a soft cloth or sponge that has been moistened with nonabrasive glass cleaner.

---

 **CAUTION:** Do not use abrasives, acetone, benzene, ammonia, ethyl alcohol, or carbon tetrachloride on any part of the printer; these can damage the printer. Do not place liquids directly on the glass or platen. They might seep and damage the printer.

---

4. Dry the glass and white plastic parts with a chamois or a cellulose sponge to prevent spotting.
5. Connect the power cable to an outlet, and then press  (the Power button) to turn the printer on.

## Check the paper settings

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. On the **Systems** tab, click **Paper Setup**.
3. Change the necessary settings, and then click **Apply**.

## Optimize for text or pictures

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. On the **Copy** tab, select the **Optimize** drop-down list.
3. Select the setting you want to use.

- **Mixed:** Use this setting for documents that contain a mixture of text and graphics.
  - **Text:** Use this setting for documents that contain mostly text.
  - **Picture:** Use this setting for documents that contain mostly graphics.
4. Change the necessary settings, and then click **Apply**.

## Edge-to-edge copying

The printer cannot print fully edge-to-edge. There is a 4 mm (1/6 in) unprintable border around the page.

Considerations for printing or scanning documents with cropped edges:

- When the original is smaller than the output size, move the original 4 mm (1/6 in) away from the corner indicated by the icon on the scanner. Recopy or scan in this position.
- When the original is the size of the printed output that you want, use the Reduce/Enlarge feature to reduce the image so the copy is not cropped.

## Wireless connectivity checklist

- Verify that the printer and the wireless router are turned on and have power. Also make sure that the wireless radio in the printer is turned on.
- Verify that the service set identifier (SSID) is correct. Print an information report to determine the SSID.  
  
On the printer control panel, press  (the Information button).  
  
If you are not sure the SSID is correct, run the wireless setup again.
- With secured networks, verify that the security information is correct. If the security information is incorrect, run the wireless setup again.
- If the wireless network is working correctly, try accessing other computers on the wireless network. If the network has Internet access, try connecting to the Internet over a wireless connection.
- Verify that the encryption method (AES or TKIP) is the same for the printer as it is for the wireless access point (on networks using WPA security).
- Verify that the printer is within the range of the wireless network. For most networks, the printer must be within 30 m (100 ft) of the wireless access point (wireless router).
- Verify that obstacles do not block the wireless signal. Remove any large metal objects between the access point and the printer. Make sure poles, walls, or support columns containing metal or concrete do not separate the printer and wireless access point.

- Verify that the printer is located away from electronic devices that might interfere with the wireless signal. Many devices can interfere with the wireless signal including motors, cordless phones, security system cameras, other wireless networks, and some Bluetooth devices.
- Verify that the print driver is installed on the computer.
- Verify that you have selected the correct printer port.
- Verify that the computer and printer connect to the same wireless network.
- For OS X, verify that the wireless router supports Bonjour.

### **The printer does not print after the wireless configuration completes**

1. Make sure that the printer is turned on and in the ready state.
2. Turn off any third-party firewalls on your computer.
3. Make sure that the wireless network is working correctly.
4. Make sure that your computer is working correctly. If necessary, restart the computer.
5. Verify that you can open the printer EWS from a computer on the network.

### **The printer does not print, and the computer has a third-party firewall installed**

1. Update the firewall with the most recent update available from the manufacturer.
2. If programs request firewall access when you install the printer or try to print, make sure you allow the programs to run.
3. Temporarily turn off the firewall, and then install the wireless printer on the computer. Enable the firewall when you have completed the wireless installation.

### **The wireless connection does not work after moving the wireless router or printer**

1. Make sure that the router or printer connects to the same network that your computer connects to.
2. Print a information report.
3. Compare the service set identifier (SSID) on the information report to the SSID in the printer configuration for the computer.
4. If the numbers are not the same, the devices are not connecting to the same network. Reconfigure the wireless setup for the printer.

### **Cannot connect more devices to the wireless printer (Wi-Fi Direct)**

1. Make sure that the other computers are within the wireless range and that no obstacles block the signal. For most networks, the wireless range is within 30 m (100 ft) of the wireless access point.
2. Make sure that the printer is turned on and in the ready state.
3. Make sure there are not more than 5 concurrent Wi-Fi Direct users.
4. Turn off any third-party firewalls on your computer.

5. Make sure that the wireless network is working correctly.
6. Make sure that your computer is working correctly. If necessary, restart the computer.


## The wireless printer loses communication when connected to a VPN

- Typically, you cannot connect to a VPN and other networks at the same time.

## The network does not appear in the wireless networks list

- Make sure the wireless router is turned on and has power.
- The network might be hidden.
- Make sure that the printer is within wireless range of the wireless router, and that there are no obstacles blocking the signal.
- The printer operates on the 2.4 GHz and 5 GHz wireless bands.
- Refresh the wireless networks list.
- Try restarting the printer.




## The wireless network is not functioning

1. To verify if the network has lost communication, try connecting other devices to the network.
2. Test network communication by pinging the network.
  - a. Open a command-line prompt on your computer.
    - For Windows, click **Start**, click **Run**, type `cmd`, and then press **Enter**.
    - For OS X, go to **Applications**, then **Utilities**, and open **Terminal**.
  - b. Type `ping` followed by the router IP address.
  - c. If the window displays round-trip times, the network is working.
3. Make sure that the router or printer connects to the same network that the computer connects to.
  - a. On the printer control panel, press  (the Information button) to print an information report.
  - b. Compare the service set identifier (SSID) on the information report to the SSID in the printer information for the computer.
  - c. If the numbers are not the same, the devices are not connecting to the same network. Reconfigure the wireless setup for the printer.

## Perform a wireless network diagnostic test

A wireless network diagnostic test can be performed using the printer control panel or the Embedded Web Server (EWS). The wireless network diagnostic test provides information about the wireless network settings.

### Method one: Perform a wireless network diagnostic test using the printer control panel

- From the printer control panel, press and hold  (the Information button) for 3 seconds, and then press  (the Information button)  (the Resume button) at the same time.

### Method two: Perform wireless network diagnostic test using the EWS

1. Open EWS. See [To access and use the Embedded Web Server \(EWS\)](#).
2. Select the **Networking** tab.
3. On the **Wireless Configuration** page, verify that the On option is selected.
4. Click the **Print Test Report** button to print a test page that shows test results.

## Reduce interference on a wireless network

The following tips can reduce interference in a wireless network:

- Keep the wireless devices away from large metal objects, such as filing cabinets, and other electromagnetic devices, such as microwaves and cordless telephones. These objects can disrupt radio signals.
- Keep the wireless devices away from large masonry structures and other building structures. These objects can absorb radio waves and lower signal strength.
- Position the wireless router in a central location in line of sight with the wireless printers on the network.

## Solve Ethernet connection problems


Check the following:

- The network is operational and the network hub, switch, or router is turned on.
- The Ethernet cable is properly connected between the printer and the router. The Ethernet cable is plugged into the Ethernet port on the printer and the light near the connector lights up when connected.
- Antivirus programs, including spyware protection programs, are not impacting your network connection to the printer. If you know that antivirus or firewall software is preventing your computer from connecting to the printer, use the [HP online firewall troubleshooter](#) to help solve the problem.
- Run the [HP Print and Scan Doctor](#) to troubleshoot the issue automatically. The utility will try to diagnose and fix the issue. The HP Print and Scan Doctor may not be available in all languages.

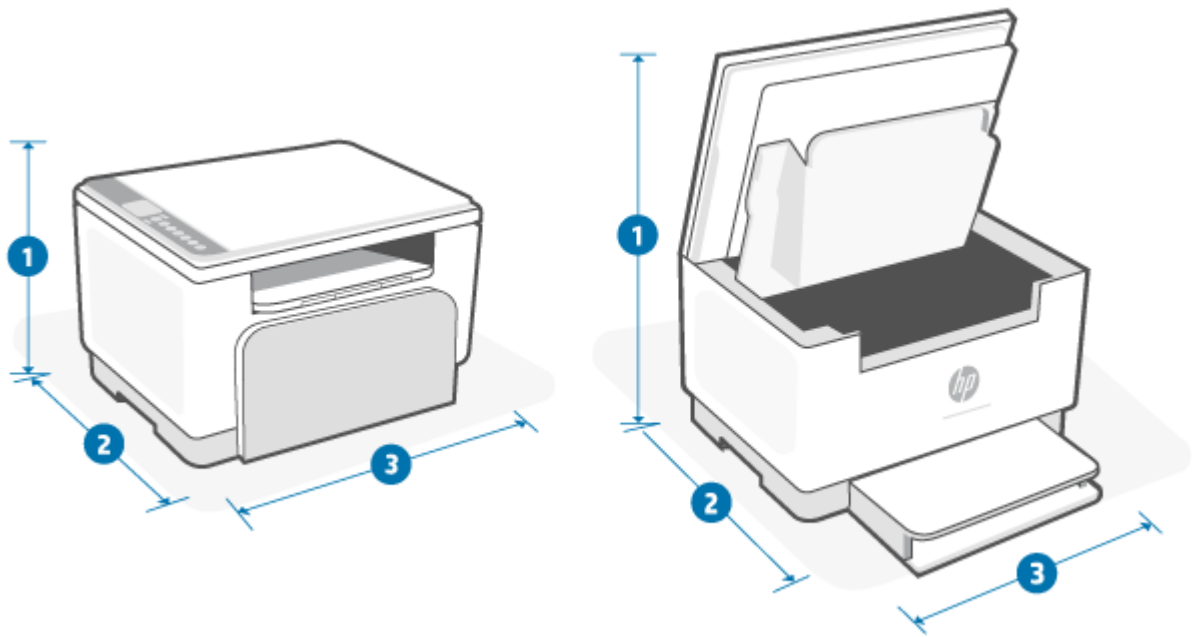

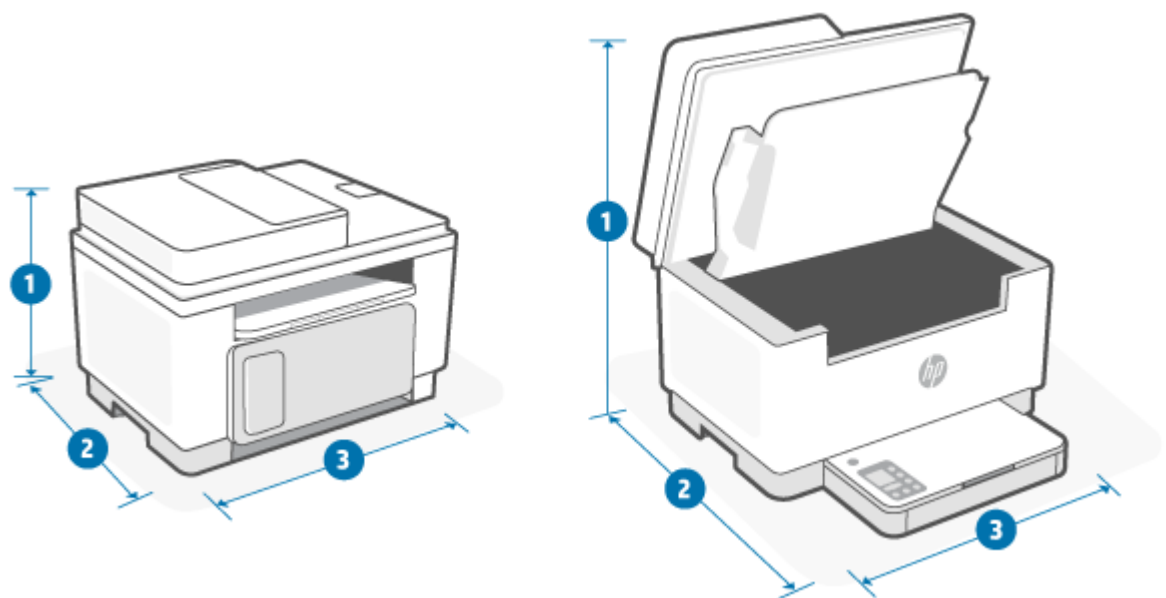

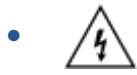
