- Do not massage an area where there is already pain or persisting pain.

## Installing the Batteries

To install the batteries, unscrew the cap on the top of the massager and remove. Place 3 AAA batteries into the battery pack with the polarities correctly aligned as shown inside the battery pack.

# Using the Massager

Once the batteries are installed, gently press the massager arms to the area you would like to massage. On contact, the massager will vibrate.

**NOTE:** The massager should be pressed gently, if the massager does not vibrate upon contact, the batteries may need to be replaced.

#### 90 Days Limited Warranty

In the unlikely event that this product is defective, or does not perform properly, you may within ninety (90) days from your original date of purchase return it to the authorized service center for repair or exchange.
