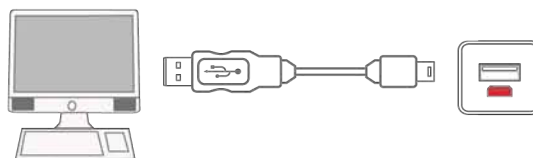
Micro USB
Charging Cable

1. Connect the large end of the Micro USB cable to the OUT Jack on the Power Bank.
2. Connect the small end of the Micro USB cable into any portable device requiring a Micro USB charging connection (please refer to your device's user guide for charging instructions).
3. Check your device's charging indicator for charging status.
4. When your device is fully charged, remove the cable from the ports.



Charging the Portable Charger

1. Connect the small end of the Micro USB cable to the IN Jack on the the battery pack.
2. Connect the large end of the Micro USB cable to an available port on your computer or other USB charging device.
3. While charging, the indicator light will quickly flash blue three times in a row. The indicator will be solid blue when the battery pack is fully charged.
4. Charge the Mobile Phone Battery Pack between 2-3 hours. Do not charge for more than 8 hours.



i Be sure to fully charge the Mobile Phone Battery Pack before using it for the first time.

90 Days Limited Warranty

In the unlikely event that this product is defective, or does not perform properly, you may within ninety (90) days from your original date of purchase return it to the authorized service center for repair or exchange.

TO OBTAIN WARRANTY SERVICE:

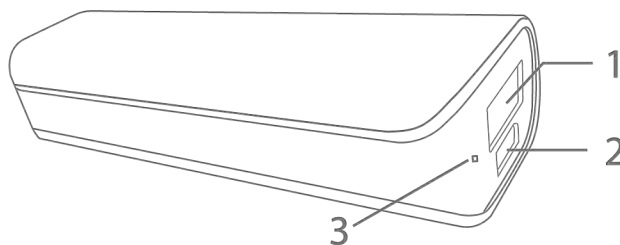

Use this port to charge the Mobile Phone Battery Pack.
3. **LED Indicator:**
Turns on when the Mobile Phone Battery Pack is being charged.
