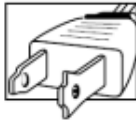
Important Safeguards

In addition to the careful attention devoted to quality standards in the manufacture process of your video product, safety is a major factor in the design of every instrument. However, safety is your responsibility too. This sheet lists important information that will help to assure your enjoyment and proper use of the video product and accessory equipment. Please read them carefully before operating and using your video product.

Installation

- 1. Read and Follow Instructions** - All the safety and operating instructions should be read before the video product is operated. Follow all operating instructions.
- 2. Retain Instructions** - The safety and operating instructions should be retained for future reference.
- 3. Heed Warnings** - Comply with all warnings on the video product and in the operating instructions.
- 4. Polarization** - Do not defeat the safety purpose of the polarized or grounding-type plug.

A polarized plug has two blades with one wider than the other.



A grounding type plug has two blades and a third grounding prong.

The wide blade or the third prong are provided for your safety.



If the provided plug does not fit into your outlet, consult an electrician for replacement of the obsolete outlet

- 5. Power Sources** - This video product should be operated only from the type of power source indicated on the marking label. If you are not sure of the type of power supply to your location, consult your video dealer or local power company. For video products intended to operate from battery power, or other sources, refer to the operating instructions.
- 6. Overloading** - Do not overload wall outlets of extension cords as this can result in the risk of fire or electric shock. Overloaded AC outlets, extension cords, frayed power cords, damaged or cracked wire insulation, and broken plugs are dangerous. They may result in a shock or fire hazard. Any mounting of the product should follow the manufacturer's instructions and use a mounting accessory recommended by the manufacturer.



Service

13. **Servicing** - Do not attempt to service this video equipment yourself as opening or removing covers may expose you to dangerous voltage or other hazards. Refer all servicing to qualified service personnel.
14. **Conditions Requiring Service** - Unplug this video product from the wall outlet and refer servicing to qualified service personnel under the following conditions.
 - A. When the power supply cord or plug is damaged.
 - B. If liquid has been spilled or objects have fallen into the video product.
 - C. If the video product has been exposed to rain or water.
 - D. If the video product does not operate normally by following the operating instructions. Adjust only those controls that are covered by the operating instructions. Use

19. **Cleaning** - Unplug the video product from the wall outlet before cleaning. Do not use liquid cleaners or aerosol cleaners. Use a damp cloth for cleaning.
20. **Product and Cart Combination** - Video and cart combination should be moved with care. Quick stops, excessive force, and uneven surfaces may cause the video product and car combination to overturn.
21. **Object and Liquid Entry** - Never push objects for any kind into this video product through openings as they may touch dangerous voltage points or "short-out" parts that could result in a fire or electric shock. Never spill liquid of any kind on the video product.
22. **Lightning** - For added protection for this video product during a lightning storm, or when it is left unattended and unused for long periods of time, unplug it from the wall outlet and disconnect the antenna or cable system. Getting Started

The SHS-2S comes with the following components:



2-Channel Camera Switcher



2 x Weatherproof Color Day/Night IR Cameras



2 x 57' DIN Extension Cables



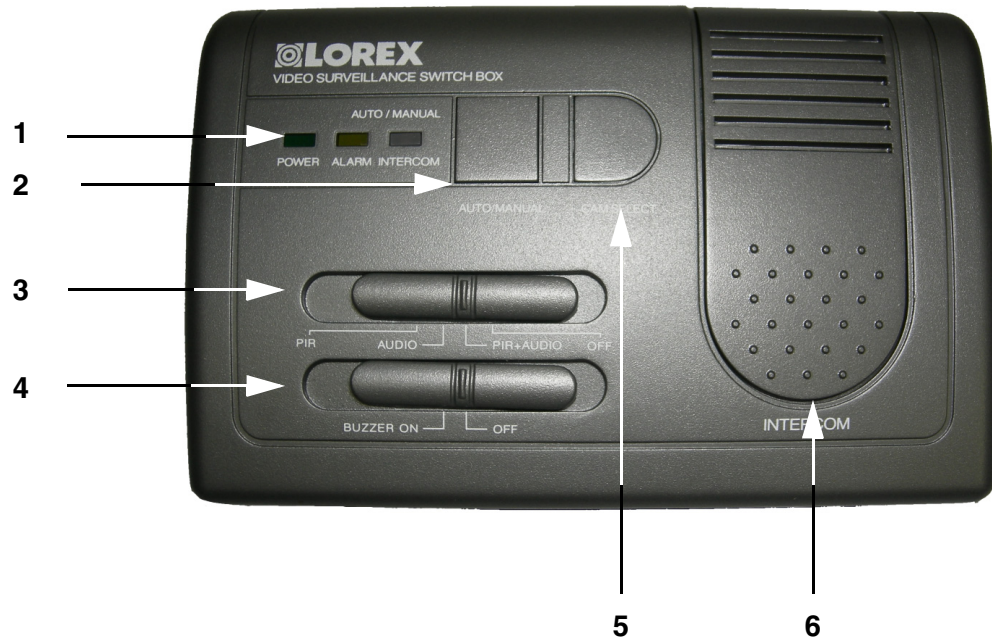
AV Cable

CHECK YOUR PACKAGE TO CONFIRM THAT YOU HAVE RECEIVED THE COMPLETE SYSTEM, INCLUDING ALL COMPONENTS SHOWN ABOVE.

SHS-2S - Front View



1. MULTICOLORED LED INDICATORS- Three LED indicators with different colors:

- Green - Indicates the Power Status (On/OFF)
- Yellow - Indicates the Alarm Status (Alarm Detected)
- Orange - Indicates the Intercom Status (Intercom is ON/OFF)

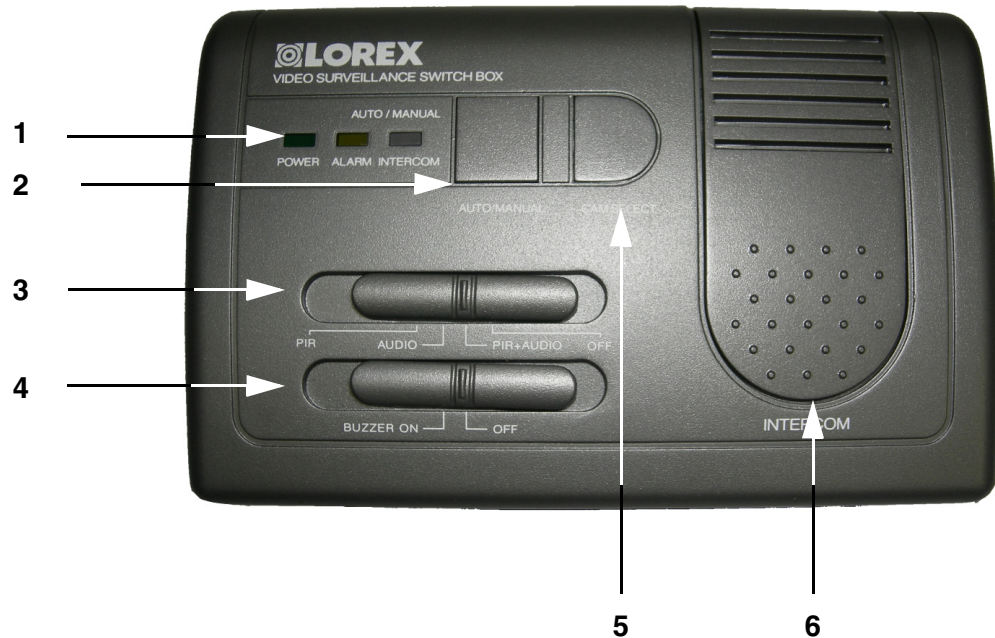
2. AUTO/MANUAL SCAN BUTTON - Scans through the available cameras. When the switcher is initially powered on, the scan type is set to AUTO and will cycle through all available cameras (CAM1-CAM2), displaying one image at a time. The GREEN LED indicator will be ON or flashing to indicate the switcher is in AUTO SCAN mode.

The AUTO SCAN has a default of 2 seconds per channel. To change this setting, press and hold the CAM SELECT button for 2 seconds to set the preferred duration:

- 2 Second Display Interval - The GREEN LED is solid
- 5 Second Display Interval - The GREEN LED will flash (fast flash)
- 10 Second Display Interval - The GREEN LED will flash (slow flash)

To view a specific camera, press the AUTO/MANUAL button to set the switcher to Manual mode (The GREEN LED will be OFF). Individual cameras can be viewed by pressing the CAM SELECT button.

SHS-2S - Front View



3. **PIR / AUDIO TRIGGER** - Sets the Alarm Type to PIR Only (Alarm will be triggered when motion is detected by the PIR), Audio (Alarm will trigger when the built-in microphone detects a sound level exceeding the set level), PIR+AUDIO (Alarm will trigger when the PIR / Audio sensors are triggered), or the alarm can be set to OFF.

NOTE: The PIR Functionality ONLY works with PIR Cameras or with the Camera PIR Accessory. Not included with the SHS-2S.

4. **BUZZER ON/OFF** - Turns the Alarm buzzer ON or OFF
5. **CAMERA SELECT** - Switches between CAM1 and CAM2
6. **INTERCOM & MICROPHONE** - Enables 2-way communication between the Cameras and the SHS-2S Switchbox (through TV/Monitor speaker).

SHS2S - Side View



1. **AUDIO SENSITIVITY 2** - Sets the Audio Sensitivity for CAM2 from Low to High by moving the switch left or right.
2. **AUDIO SENSITIVITY 1** - Sets the Audio Sensitivity for CAM1 from Low to High by moving the switch left or right.
3. **ALARM TIME DURATION** - Sets the Alarm Time Duration from 5 Seconds to 30 seconds by moving the switch left or right.

SHS-2S - Rear View



1. **CAM1 - CAM2 DIN INPUTS** - Camera inputs (for cameras with 6 pin DIN connection).
2. **DIN OUTPUT** - Connects the DIN A/V cable to a TV/Monitor.
3. **DC 15V** - Connects the 15V DC Power adapter

The SHS-2S switcher includes 2 CMOS Color IR Day/Night Indoor/Outdoor Cameras*



* Picture changes from Color to B&W under low light conditions.

Camera Installation

Before you install the camera, carefully plan where and how you will position the camera, and where you will route the cable that connects the camera to the SHS-2S switcher.

Installation Warnings:

- Select a location for the camera that provides a clear view of the area you want to monitor, which is free from dust, and is not in line-of-sight to a strong light source or direct sunlight.
- Plan the cables' route so that it is not close to power or telephone lines, transformers, microwave ovens or other electrical equipment that could interfere with the system.
- Select a location for the camera that has an ambient temperature between 14°F~113°F (-10°C~45°C)
- If you plan to install the camera in a location that has conditions not recommended in this manual, consult with a professional installer and consider use of a separate camera cover or housing
- Before starting permanent installation, have another person hold the camera for you while you verify its performance by observing the image on the monitor.

Camera Stand Installation:

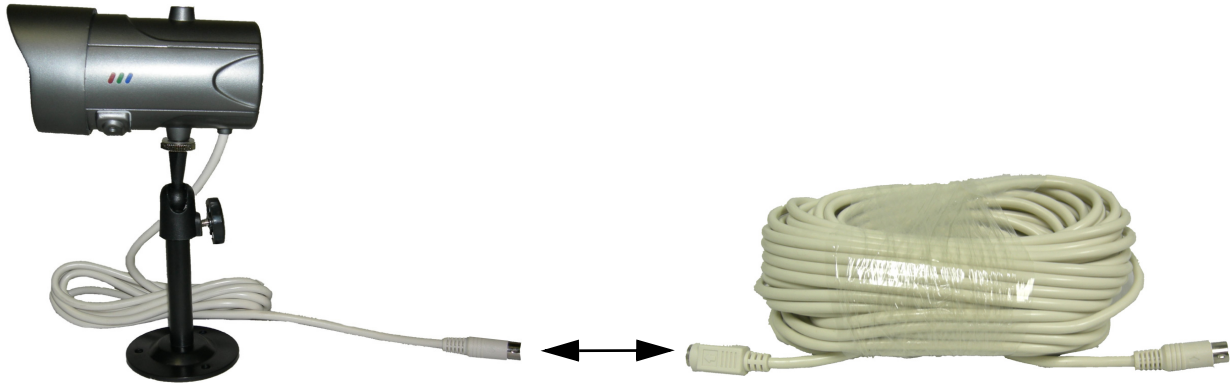
1. Attach the pedestal to the ceiling, wall or other surface by the base using the provided screws.
2. The mounting bracket must be attached to a structural device such as a wall stud or ceiling rafter using the supplied screws.
3. Attach the camera to the pedestal. Adjust the angle of the camera, and tighten the thumbscrew to set the position



NOTE: The Camera can be attached to the stand using the screw point on the top or the bottom (to maintain proper camera alignment). This prevents the image from becoming inverted.

Connecting Cameras

1. Connect the female end of the supplied 57' extension cable to the camera.



NOTE: Confirm that the arrows on the DIN Camera Cable and the DIN Extension cable are pointed together when connecting the cable. If the pins in the DIN Cable are bent, the Camera will NOT function.



2. Connect the male end of the supplied 57' extension cable to an open camera input on the back of the SHS-2S switcher. Continue connecting additional DIN cameras.

NOTE: The arrow on the DIN Camera should be facing up when connecting the DIN Extension Cable to the SHS-2S switcher.



Connecting the SHS-2S A/V Cable

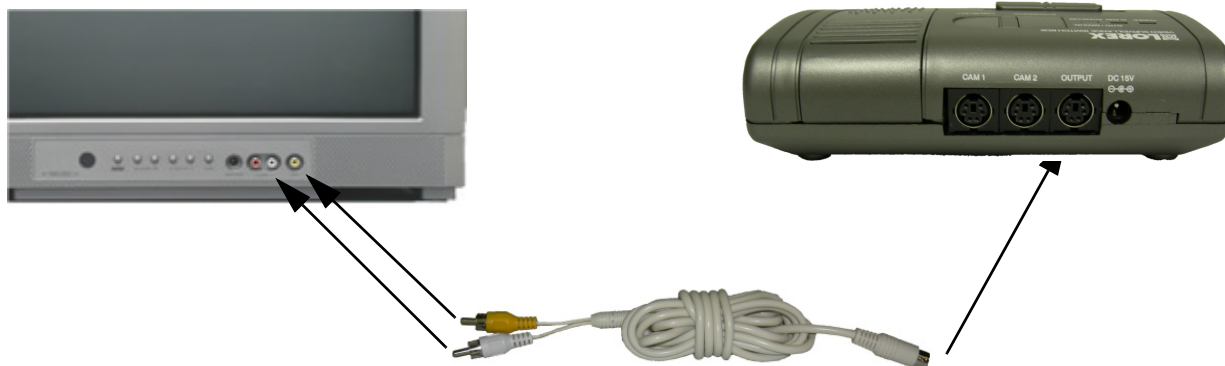
Connect the DIN end of the A/V Cable to the SHS-2S Switcher. Connect the RCA Video and Audio cables to the TV, VCR or Monitor.

TV / VCR / MONITOR

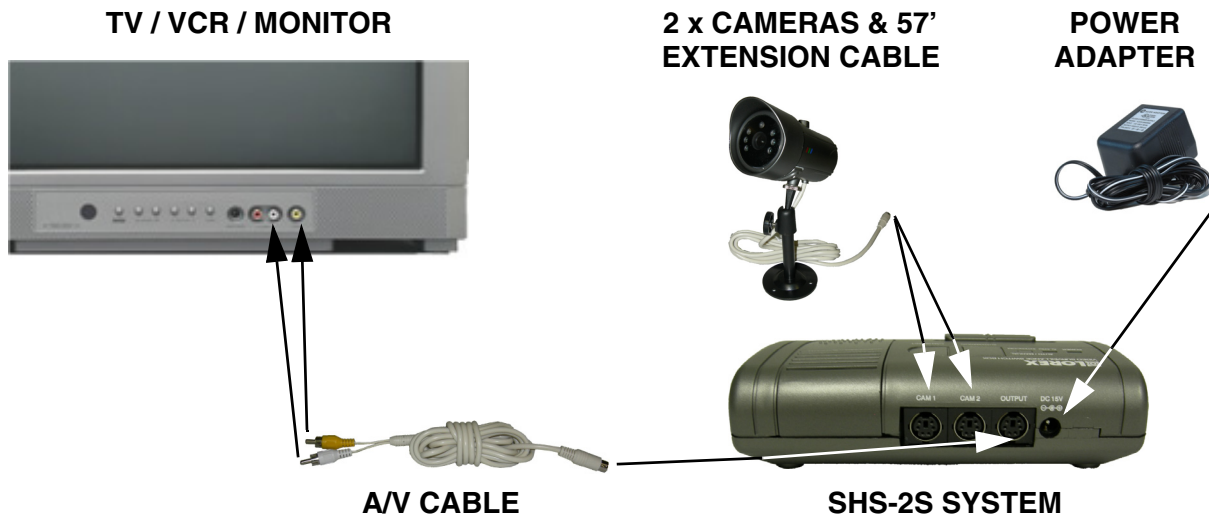
Connect the Yellow AV Cable end to an available video port, and the White AV Cable end to an available audio port.

SHS-2S

Connect the DIN Cable end to the OUTPUT port
