Introducing the Polycom Mobile Responder









The Polycom Mobile Responder is a complete video conferencing system packaged in a portable case. Based on Polycom's VSX 8000 system, the Mobile Responder includes a built-in display, camera, microphone, speaker, and IP network interface.

Because it is transportable and quick to set up, the Mobile Responder is ideal for anyone who wants to accomplish more while on the road or in the field. It is especially suited for rapid deployment and first-responder applications, such as homeland security, emergency management, military communications, and police and firefighters. The Mobile Responder complies with FAA carry-on luggage regulations.



System Components

These standard components come with the Polycom Mobile Responder:

Name	Component	Description
Polycom Mobile Responder		The Polycom Mobile Responder is a transportable video conferencing system. The system offers built-in components, such as a display and camera, a connection panel that enables you to connect additional components, and the VSX 8000 user interface.
VGA cable		The VGA cable enables you to connect your Mobile Responder to an optional projector or an additional display.
Power cables for North America, United Kingdom, and Europe		The power cable connects power to the Mobile Responder. Use the cable that's appropriate for your country.
LAN cable		The LAN cable connects the Mobile Responder to an IP network.
S-video to RCA adapter		The S-video to RCA adapter enables you to connect a composite video output device, such as some cameras and VCRs, to the Mobile Responder.
VSX 8000 remote control		The remote control is designed to make it easy to set up and operate the system — color-coded buttons correspond to system features.
Remote tether		The remote tether enables you to connect the remote control to the Mobile Responder so that you do not lose the remote control.

You may also add optional components to your Mobile Responder. For example, you can add:

- QBRI, PRI, or V.35 network interface modules
- A laptop
- A Polycom PowerCam™ camera, a PowerCam Plus camera, or a camera from a different manufacturer
- A Polycom VSX microphone array or a SoundStation VTX 1000® conference phone
- An additional display or a projector
- A headset, handset, or headphones

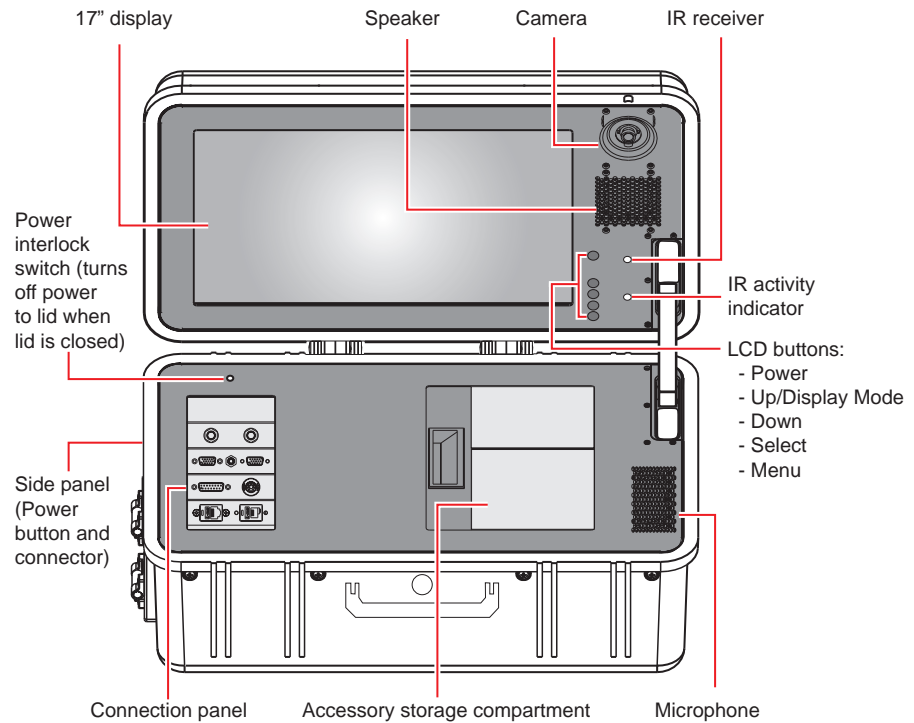
Setting Up and Using the Polycom Mobile Responder

The Polycom Mobile Responder was specifically designed to be easy to set up. Many components, such as the camera and display, are built in, so they're ready to use at a moment's notice. If you want to add optional components, the connection panel is right inside the case so you can easily connect any cables you need. Once all your components are set up and you power on the Mobile Responder, you're ready to use the system.

This chapter describes how to set up the Mobile Responder, refers you to the documentation you need for more information about performing video conferencing functions, and provides helpful tips about using the system.

Identifying System Parts

The following illustration identifies the major parts of the Mobile Responder:



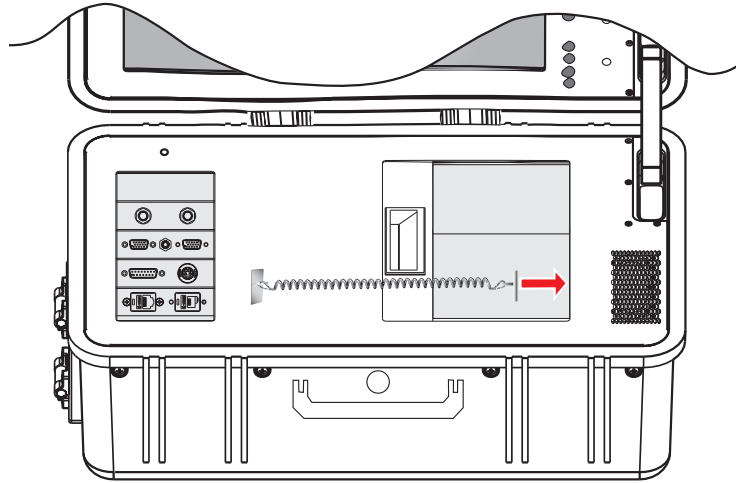
Attaching the Remote Tether

To operate the Mobile Responder, you need the remote control. If you are using the Mobile Responder in an environment where you could lose the remote, you can attach it to your Mobile Responder using the remote tether.

Keep in mind that once you attach the remote control, you cannot remove it and attach it to a different location.

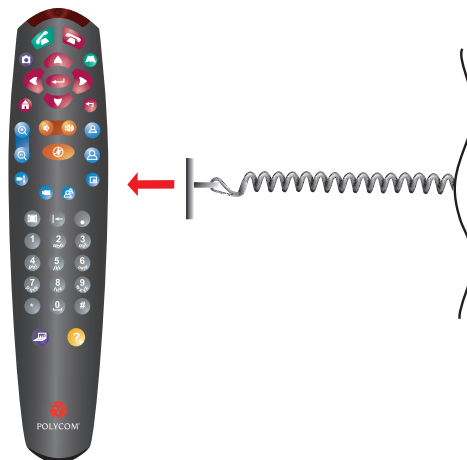
To attach the remote tether:

1. Peel the backing off one side of the remote tether, and stick it to the inside wall of the accessory storage compartment:



By sticking the remote tether to the inside wall of the accessory storage compartment:

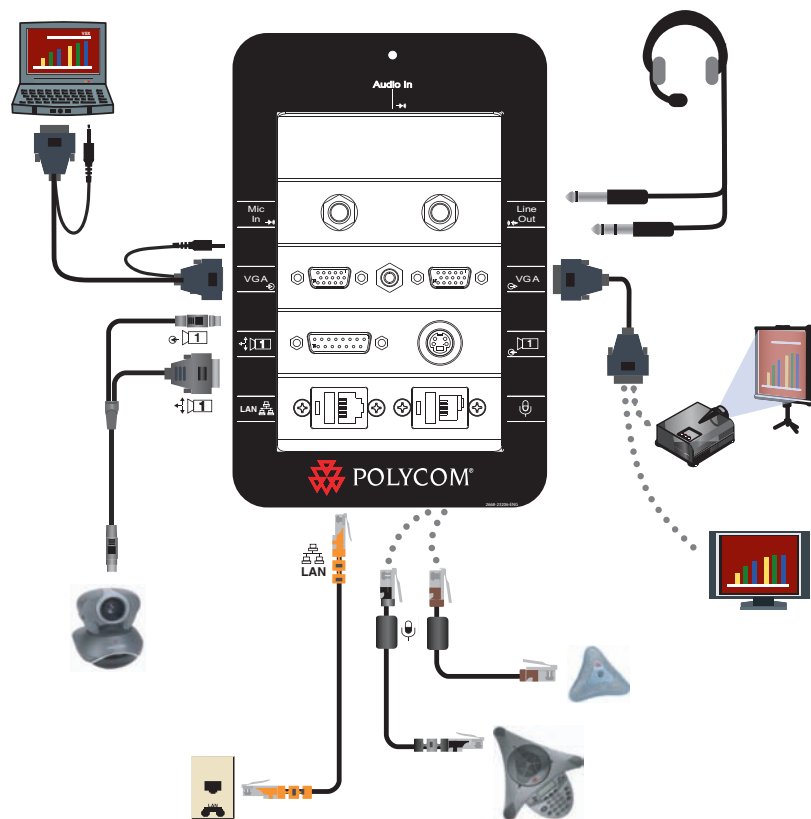
- The remote tether remains out of the way of items stored inside the compartment.
 - You can close the Mobile Responder lid without damaging the display or any other components.
2. Peel the backing off the other side of the remote tether, and stick it to the side of the remote control:













Connecting Equipment to the Connection Panel

The Mobile Responder comes with built-in components, including the camera, microphone, display, and speaker. However, if you want to connect additional components to the system, you can do so very easily by using the connection panel.

The following illustration shows some of the optional components you can connect to the connection panel. To purchase optional components, contact your Polycom distributor.



This connector...	Enables you to...
Mic In 	Connect to an external speaker system, headset, or handset. If you connect a device to the Mic In connector, the Mobile Responder's internal microphone is deactivated. The internal microphone reactivates as soon as you disconnect the external device from this connector.
Line Out 	Connect to a sound system or a headset. Because the internal speaker does not receive stereo audio, you must connect to an external sound system if you want to receive stereo audio. If you connect a sound system or headset to the Line Out connector, the Mobile Responder's internal speaker is deactivated. The internal speaker reactivates as soon as you disconnect the external sound system or headset from this connector.
VGA In 	Connect video from a computer or a laptop. For more information on how to connect a computer or laptop to the VGA In connector, refer to the <i>Administrator's Guide for the VSX Series</i> , available on the VSX Series documentation CD that comes with the Mobile Responder.
Audio In 	Connect audio from a computer or a laptop or from an external line-level source, such as audio from a VCR or DVD player. If you connect audio from a VCR or DVD player to the Audio In connector and you want to hear the audio from your VCR or DVD player, you must: <ul style="list-style-type: none"> • Set the Line Input (Red) and Line Input (White) settings to VCR (for more information about how to set these, refer to the audio settings table on page 2-11). • Press  Camera on the VSX 8000 remote control and select Camera 1. For more information about the VSX 8000 Admin Settings, refer to the <i>Administrator's Guide for the VSX Series</i> , available on the VSX Series documentation CD that comes with the Mobile Responder.
VGA Out 	Connect to an external display, such as a different monitor or a projector. If you connect another monitor, this monitor displays the same video as the Mobile Responder's built-in display.

This connector...	Enables you to...
Camera 1 Control and Camera 1 In  	Connect to an external camera, such as a Polycom PowerCam or PowerCam Plus. Alternatively, you can use the Camera 1 In connector to connect video from a VCR or DVD player. If you connect an external NTSC camera to the Camera 1 In connector, the Mobile Responder's internal camera remains activated. However, if you connect an external PAL camera to the Camera 1 In connector, the internal camera is deactivated and the screen turns blue. For information on how to proceed once you have connected an external PAL camera, refer to page 3-3.
LAN 	Connect to an IP network.
Conference-Link 	Connect to an external digital microphone, such as a Polycom VSX microphone array or a SoundStation VTX 1000 conference phone. Because the internal microphone does not send stereo audio, you must connect an external digital microphone if you want to send stereo audio. If you connect a device to the Conference-Link connector, the Mobile Responder's internal microphone remains activated.

Installing the Optional QBRI, PRI, or Serial Network Module

The Mobile Responder comes standard with an IP network interface. If you want to connect to another network interface, such as ISDN QBRI, ISDN PRI, or a serial network interface (V.35, RS-530, or RS-449), you must order the optional network module, install it, and then configure the new network interface.

You can continue to use IP with any of the optional network modules; however, you cannot use more than one optional network module at the same time. For example, you cannot use QBRI and V.35 at the same time.

To install the optional QBRI, PRI, or serial network module:

1. Make sure that the power is off.

2. Using a slotted screwdriver, open the back panel of the Mobile Responder by rotating the lock 180 degrees:



3. Remove the back panel.
4. Using a Phillips screwdriver, unscrew the plate inside, and remove it as well.
5. Slide in the network module all the way to the back:



6. Tighten the screws on each side of the network module.



7. If you plan to use the optional network interface right away, attach the network cable to the module. If you do not plan to use the optional network interface for some time, you may want to replace the back panel to maintain water and sand resistance.
8. Configure the VSX 8000 for use with the new network interface. For example, for ISDN QBRI, you must enable ISDN H.320, enter the number assigned to each channel, and so forth.

For information how to configure your new network interface, refer to the *Administrator's Guide for the VSX Series*, which is available on the VSX Series documentation CD that comes with the Mobile Responder or at www.polycom.com/videodocumentation.

Powering On the Mobile Responder

After you have connected any additional equipment to the Mobile Responder, you can connect the power cable and then power on the Mobile Responder.

The power consumption for the Mobile Responder is listed in the following table:

During this time...	The power consumption is...
Startup	0.5 amp to 1 amp @ 100 - 240 VAC
Running idle	1.2 amps @ 100 - 240 VAC
LAN call	1.2 amps @ 100 - 240 VAC

To connect the power cable:

1. Open the side panel of the Mobile Responder by pressing down on the latch. Inside the side panel is the power connector and Power button.



2. Make sure you have the appropriate power cable for your country, and connect one end of the cable to the power connector inside the side panel.
3. Connect the other end of the power cable to a wall outlet.



Note

The Mobile Responder can accept AC voltages between 98 and 250 VAC.

To power on the Mobile Responder:

1. Press the Power button located inside the side panel to the ON position.
2. Wait one to two minutes for the system to completely power on.

When the system is powered on, the VSX 8000 home screen appears on the display.

Performing Video Conferencing Tasks

Because the Mobile Responder is based on Polycom's VSX 8000 video conferencing system, you can use your Mobile Responder to perform virtually all of the video conferencing tasks that you can perform with a VSX 8000. For example, you can place and end video calls, share data, customize the look and behavior of the system for your particular needs, and so on.



For complete information about how to use the VSX 8000 to place calls and perform other video conferencing tasks, refer to the *Administrator's Guide for the VSX Series* and the *Getting Started Guide for the VSX Series*. Both of these documents are available on the VSX Series documentation CD that comes with the Mobile Responder or at www.polycom.com/videodocumentation.

Tips on Using the Mobile Responder

- The Mobile Responder weighs 39 pounds (18 kilograms). You should get help lifting it if you cannot carry this much weight.
- Although the Mobile Responder is built to withstand the rigors of travel, you should handle it as you would handle a laptop. For example, if you are traveling by air, be sure to bring the Mobile Responder with you as a carry-on, and place it carefully in the overhead storage compartment.
- Operate the Mobile Responder in an environment within the range of 15% to 90% relative humidity.
- Store the items you use with your system, such as the remote control and power cable, inside the accessory storage compartment.
- To avoid damaging the display, close the accessory storage compartment and remove any cables connected to the connection panel before closing the case.
- You can manually pan and tilt the camera; however, it has a fixed focus.
- To bring up the pull-out handle on the Mobile Responder, push the latch to the right. You can then conveniently pull the system along on its two wheels, just as you would roll a suitcase.
- For extra security, add a padlock to the system using the holes on each side of the handle.
- Typically, you should not need to adjust the display. However, if you do need to make adjustments, you can use the LCD buttons to the right of the display (for an illustration of where these buttons are located, refer to [Identifying System Parts](#) on page 2-2).

Restoring System Settings





If you reset the VSX 8000 to the factory defaults and delete the system settings, follow these steps to restore the system settings for the Mobile Responder:

1. Press and hold down the  button on the remote control while powering on the Mobile Responder. Hold the  button until the Polycom logo appears on the screen.
2. Use the remote control to select a language, and then follow the remaining screens in the setup wizard.
3. Set these camera settings:

This chapter presents problems, likely causes, and corrective actions for the Mobile Responder. Problems are organized by category to help you troubleshoot them quickly.

You can find additional troubleshooting information in the *Administrator's Guide for the VSX Series*, which is available on the VSX Series documentation CD that comes with the Mobile Responder or at www.polycom.com/videodocumentation. This document can help you identify and correct issues associated with the VSX 8000, such as problems accessing system screens or problems making video calls.

If you have referred to the documentation and you still are unable to resolve your issue, contact Polycom Technical Support. The last section of this chapter tells you how to do so.

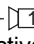

Power

Symptom	Problem	Corrective Action
The system does not start or respond in any way.	The Power button is off.	<ol style="list-style-type: none"> 1. Press the Power button located inside the side panel to the on position. 2. Wait one to two minutes for the system to completely power on.
	The power cable is not connected.	Make sure the power cable is connected to a power outlet, and that the power cable is seated securely both in the outlet and in the Mobile Responder.
	The power outlet is not active, or the system's power cable is not operating properly.	<p>Check the power outlet by unplugging the system and plugging in a lamp, radio, or other small appliance. If it does not operate, the outlet is not active — connect the system to a different outlet.</p> <p>If the outlet is active, the problem may be in the Mobile Responder's power cable. In this case, call Polycom Technical Support.</p>
	The power interlock switch is pushed down.	Make sure that the power interlock switch, which turns off power to the lid, is up (refer to Identifying System Parts on page 2-2 for an illustration showing where the power interlock switch is located).
The screen is blank.	The system is in standby mode.	Pick up the remote control to activate the system.
	The power for the display is off.	Press the LCD Power button to turn the display on (refer to Identifying System Parts on page 2-2 for an illustration showing where the LCD Power button is located).
	The wrong display mode is selected.	Press the LCD Up/Display Mode button until you set the display mode to RGB (refer to Identifying System Parts on page 2-2 for an illustration showing where the LCD Up/Display Mode button is located).

Symptom	Problem	Corrective Action
The screen is blue.	You connected an external PAL camera to the Camera 1 In  connector, which deactivates the internal camera.	<p>Do one of the following:</p> <ul style="list-style-type: none"> If you plan to use an external PAL camera all of the time, go to System > Admin Settings > Cameras and set the Primary Camera setting to 1. If you want to view video from the external PAL camera, but do not plan on using this camera all of the time, press  Camera on the remote control and select the appropriate camera source. <p>Note that when you disconnect the external PAL camera, the internal camera reactivates. To view video from the internal camera, press  Camera on the remote control and select the appropriate camera source.</p>
No video from the external camera.	Camera inputs and outputs are not connected correctly.	Refer to Connecting Equipment to the Connection Panel on page 2-4 for information on how to connect an external camera correctly.
	You connected a composite video output device using the S-video to RCA adapter, but you did not set the video format to Composite .	Go to System > Admin Settings > Cameras (page 2) and set the Video Format setting to Composite .
The video is not centered on the LCD screen.	The screen is not calibrated correctly.	<p>The Mobile Responder comes with an auto-calibration feature. Cannot receive or send stereo audio. Symptom	Problem	Corrective Action
The people at the far site cannot hear you or you cannot hear them.	The people at your site or at the far site are too far from the microphone.	Move closer to the microphone or turn up the volume using the remote control. Also, if you are using an external microphone, check that the microphone is correctly connected.
	The microphone at your site or at the far site is muted.	Make sure all microphones are not muted. To unmute a microphone, you can press Mute on the remote control or, with some external microphones, you can press Mute on the microphone itself.
	Your system's microphone does not work.	Contact your Polycom reseller.
	Audio inputs and outputs are not connected correctly.	Refer to Connecting Equipment to the Connection Panel on page 2-4 for information on how to connect microphones and other audio equipment correctly.
	Too many line errors or other audio issues.	Refer to the <i>Administrator's Guide for the VSX Series</i> for more audio troubleshooting information.
No audio from the VCR or DVD player.	You connected a VCR or DVD player, but you did not specify the appropriate VSX 8000 settings.	<p>If you connect audio from a VCR or DVD player to the Audio In connector and you want to hear the audio from your VCR or DVD player, you must:</p> <ul style="list-style-type: none"> Set the Line Input (Red) and Line Input (White) settings to VCR (refer to the audio settings on page 2-11 for more information about how to set these). Press  Camera on the remote control and select Camera 1. <p>Refer to the <i>Administrator's Guide for the VSX Series</i> for more information about the VSX 8000 Admin Settings.</p>
No audio from a PC microphone or from a PC headset with a microphone.	The Mobile Responder does not support condenser (electret) microphones that require a bias voltage.	<p>Switch to a microphone supported by the Mobile Responder, including:</p> <ul style="list-style-type: none"> Any dynamic microphone. Most professional condenser microphones that require phantom power. Most professional condenser microphones that operate on an external battery.
The system does not respond to the VSX remote control.	The batteries in the remote control are low, dead, or missing.	Install three AAA batteries in the remote control.
	The batteries are installed incorrectly in the remote control.	Insert the batteries in the correct +/- position.
	The IR receiver is not receiving signals from the remote control.	Make sure you are pointing the remote control at the IR receiver, which is located below the speaker on the Mobile Responder (refer to Identifying System Parts on page 2-2 for an illustration showing where the IR receiver is located).
