

Guarantee and Compensation

Barco provides a guarantee relating to perfect manufacturing as part of the legally stipulated terms of guarantee. On receipt, the purchaser must immediately inspect all delivered goods for damage incurred during transport, as well as for material and manufacturing faults Barco must be informed immediately in writing of any complaints.

The period of guarantee begins on the date of transfer of risks, in the case of special systems and software on the date of commissioning, at latest 30 days after the transfer of risks. In the event of justified notice of complaint, Barco can repair the fault or provide a replacement at its own discretion within an appropriate period. If this measure proves to be impossible or unsuccessful, the purchaser can demand a reduction in the purchase price or cancellation of the contract. All other claims, in particular those relating to compensation for direct or indirect damage, and also damage attributed to the operation of software as well as to other services provided by Barco, being a component of the system or independent service, will be deemed invalid provided the damage is not proven to be attributed to the absence of properties guaranteed in writing or due to the intent or gross negligence or part of Barco.

2.1 About the ClickShare product

ClickShare sets

ClickShare makes connecting to the meeting room's video system a matter of clicking a Button. This one click wonder not only helps the presenter get the presentation on-screen in a second, but it also allows the other people in the meeting to participate more actively. The result is enhanced meeting efficiency and better decision-making.

At the moment 4 different sets are available on the market. Each set is sold in its specific region and it can only be used in that specific region.

Components ClickShare set

A standard ClickShare set consists of a Base Unit, a Tray and 4 Buttons. Depending on the location where you buy the product, the software of the Base Unit is different. If needed, you can buy additional Buttons and Trays.




Image 2-1 ClickShare main components

2.2 About the Base Unit

Base Unit functionality

The Base Unit receives the wireless input from the Buttons and controls the content of the meeting room display and the sound of the meeting room's audio system.

The Base Unit can be inside a cabinet in the meeting room, or put on the meeting room table or mounted on a wall or ceiling. Check the Installation Guide for instructions on how to install the Base Unit.




Image 2-3 The Base Unit

USB Port

The USB port is used to update the software of both the Base Unit and the Buttons.

When plugging in the Button into the Base Unit, the Button is paired to the Base Unit. The Base Unit checks whether the software and firmware of the Button is up to date. If not, the Base Unit updates the software and/or firmware.

Status LED strips

The color of the LEDs at the front of the Base Unit give information on the status of the system.

LEDs behavior	Explanation
static red	 receiving content from the Buttons and streaming towards the display. pairing and software update of the Button is done. You can now unplug the Button from the Base Unit. during the first phase of the Base Unit boot process.
blinking white	 system is starting up (during the second phase) Button pairing is in progress software update of the Base Unit

Standby button

The button at the front of the Base Unit has a power on/off function and a standby function.

- When the system is awake, a short push triggers the system to go into standby mode.
- When the system is in standby mode, a short push triggers the system to wake up.
- When the system is powered on, a long push makes the system to shut down and power off.
- When the system is shut down, a long push or short push triggers the system to start up.

2.3 About the Button

Button functionality

By default, the ClickShare Set comes with four Buttons. A Button contains three main functional components.




Image 2-4 The Button

Handle the Button cable with care. Rough handling might cause defects.

USB connector

Using the USB connector the Button can be plugged into a laptop (for sharing your screen) or in the Base Unit (for pairing the Button to the Unit or updating its software).

Button

Click the Button to display the content of the laptop's screen on the meeting room display. Clicking the Button during the meeting will toggle the sharing of the screen.

Holding the Button for 2 seconds brings the content of the laptop's screen as full screen on the meeting screen, removing other sources currently displayed.

LED ring

The LED ring indicates the current status of your ClickShare.



2.4 About the Tray

Tray functionality

The function of the Tray is to hold the Buttons on the table when the meeting has finished. The Tray can hold up to 4 Buttons.




2.5 ClickShare App

Introduction

The ClickShare App is freely available from the Apple store. It allows one to display static content such as PDF and JPG documents on iPads and iPhones.

The App is like a virtual Button, including the multiple on screen composition and the show-me-only capability. Content from tablet devices running the App is treated by the Base Unit just like content coming from a physical Button. Although the App does not provide an exact real-time mirroring of the client device's screen like the Button (which is not possible for technical and legal reasons), it is a bit better than pure static content in the sense that also zooming in and out using the pinch gesture and annotating using a virtual pen are possible. The App also has a shot-and-show capability. This means that while the App is running in the background, a picture taken with the built-in camera or a snapshot taken using the two button gesture will automatically be sent to the Base Unit.

Before you can use your iOS device with the ClickShare App, you have to connect the wifi with the ClickShare SSID. Follow the instructions as given in your iOS device user guide.





3.1 Powering the Base Unit on and off

About power mode

You can power on and off the Base Unit and bring the system in standby mode. In standby mode the system mutes the output signal to the display. If your display supports this, it will automatically enter power saving mode.

To power on the Base Unit or awake it from standby

1. When the Base Unit is shut down, set the rocker switch at the back of the Base Unit to "I". Refer to image 3-1.





Image 3-1 Rocker switch

2. If the system does not start up automatically, push the standby button shortly. Refer to image 3-2.



The system is now powered on.

To put the Base Unit in standby mode or awake it

1. Push the standby button shortly. Refer to image 3-2.

Note: If you plug in a Button into your laptop and connect to it, the Base Unit automatically wakes up from standby (enable its display output).

If no Buttons have been connected to it for some time, the Base Unit can automatically enter standby mode.

To shut down the Base Unit

The Base Unit can be shut down in two ways:

- 1. Push the standby button until the Base Unit shuts down. Refer to image 3-2.
- 2. Set the rocker switch at the back of the Base Unit to "0". Refer to image 3-1.

Basic Use 3.2

Basic functionality

When entering a meeting room equipped with ClickShare and if the display is not in power saving mode, the ClickShare wallpaper is shown on the display. The content of the wallpaper depends on the setup.

To start using ClickShare

1. Take a Button out of the Tray.







When the system is ready for use, a message appears close to the systray icon.

5. To share your screen on the display, click the Button.

The LEDs of the Button become static red and your screen appears on the display. When audio is enabled on the ClickShare Base Unit, the audio of your laptop is also available on the audio output of the Base Unit and it will be played via the meeting room audio system. The icon return to the same state as in step 4.

In the system tray, the ClickShare icon starts rotating. On Windows computers the icon changes into



The name of the user logged on to the laptop which is sharing its content is briefly shown in the bottom left corner of the added

ClickShare automatically scales the content of your screen to the resolution of the meeting room display. The aspect ratio of your screen is maintained to make sure the proportions are correct.

6. To remove your content from the display, click the Button again.

The LEDs of the Button become static white.

7. When leaving the meeting room, unplug the Button from your laptop and put it back in the Tray.

No trace of the ClickShare application is left on your laptop.

3.3 **Advanced Use**

Advanced functionality

ClickShare can show the content of up to four wireless sources or three wireless sources and one ClickShare Link (for an iPad) on the meeting room display(s) at the same time. A wireless source is a ClickShare Button, or either an iPad or android device sharing via the ClickShare app. This means by clicking their Button, clicking the virtual button in the ClickShare app or connecting an iOS device through the ClickShare Link, four persons in the meeting room can display their screens simultaneously. They appear as follows:




Image 3-9 Position on single display






Image 3-10 Position on Dual screen





If you are the fifth user who wants to share his screen, you are blocked. A message appears on your screen telling you the maximum number of users being displayed simultaneously has been reached. You can decide to wait until one of the four users removes his content from the display or you can decide to show your content full screen. In that case, the four screens that were being displayed are removed and your screen is displayed full screen.

To show your content on the display full screen

1. Click and hold the Button for 2 seconds.

Your content is shown full screen on the display. If other persons were sharing their content on the display, their screens are removed. Their Button's LEDs are now shining white again.





When you click again, your content is removed and the Base Unit shows the welcome screen again. The content of the previous users is not restored on the display.

3.4 Use of an iOS device with ClickShare Link

About using an iOS device with ClickShare Link

The content of the iOS device touchscreen can be displayed on the large meeting room display(s) as one of the possible sources. The optional ClickShare Link must be installed in the meeting room before an iOS device can participate by sharing its screen content. For more information about the physical installation of ClickShare Link in combination with an iOS device, consult ClickShare's installation guide (R5900004)

Necessary parts

- a ClickShare Link
- an HDMI cable
- · optional: an iOS device HDMI adapter or an Apple TV

Connection with cable

- 1. Connect the iOS device HDMI convertor to your iOS device.
- 2. Connect the ClickShare Link to the power and to a rear USB port of the Base Unit.
- 3. Connect the HDMI port of the iOS device to the input of the ClickShare Link.

The content of the screen will be displayed on the meeting room screen.

Connection via Apple TV

As per the above but connect the ClickShare Link input to the Apple TV instead of the iOS device.

1. Connect to the appropriate network and start sharing by enabling *AirPlay mirroring*. For more information on how to setup, consult the iOS device's user guide.

Note: Always use AirPlay mirroring. Streaming is not supported.

3.5 User Interface



Detailed capture mode may capture more details and overlays but video throughput may decrease a bit. Selecting this mode will change the window settings and switch off the GPU accelerator of the video card.



3.7 Shared desktop: primary - extended



Only for Window7 and Windows8

About shared desktop

Depending on your selection, your primary screen or your extended screen will be captured and displayed via ClickShare. That extended screen can be a physical screen or a virtual screen.

With extended desktop you can take advantage of both your laptop screen and the central meeting room display. Presentation notes or other material on primary screen will not be displayed to everyone.




Image 3-22 Shared desktop selection

Known issue

 Virtual Extended Desktop not supported on some Windows7 and Windows8 systems due to a problem in recent versions of the AMD graphical driver. Downgrade to an older version of the driver might resolve the issue.

3.8 Audio configuration

Audio configuration

The audio signals from the different users are mixed in the Base Unit to one output signal. Each connected user must control his own audio signal using the audio configuration of his computer. If he does not want to broadcast his audio signal, he has to mute audio on his computer.

For some operating system, it is necessary to set ClickShare as your default output device. Once you unplug the Button, the default setting is switched back to the previous setting.

Set ClickShare as default in Windows 7

1. Right click on the speaker icon in the system tray (1).




Image 3-23 Speakers ClickShare, default






Image 3-25 Speakers ClickShare, default

3.9 Pairing

Pairing of the Buttons with the Base Unit

To be able to use a Button it should be assigned to the Base Unit you are using. This process is called pairing. By default, the four Buttons delivered with the ClickShare set are already paired to the specific Base Unit.

In case you buy additional Buttons or when a Button should be assigned to another Base Unit, the Button needs to be paired (again). When updating the Base Unit software, it is advised to also pair your Buttons with the Base Unit to update their software.



A Button can only be paired to one Base Unit at a time.

The Button will always make connection to the Base Unit it was last paired to.

To pair a Button to the Base Unit

1. Insert the Button in the USB port at the front of the Base Unit you are using.



Both the LEDs of the Button and the LEDs of the Base Unit are blinking white. This means pairing is in progress.

The Base Unit automatically checks whether the software of the Button is up to date. If not, the Base Unit updates the Button software. This may take more time.

During the pairing and update process, a message is displayed on the screen: "Pairing and updating Button. Busy pairing and updating"

The result of the pairing process can be as follows:

- When the LEDs become static white, the Button is paired to the Base Unit, but no software update was needed. You can unplug the Button from the Base Unit.
- When the LEDs become static red, the Button is paired to the Base Unit and the software update has finished. You can unplug the Button from the Base Unit.




Image 3-29 Unplug Button from Base Unit

Problem solving

In this chapter some problems that might occur while using ClickShare are listed. For each problem possible causes are given and a solution is proposed. If you cannot solve the problem yourself, please contact your local IT administrator.
